A post-race vet examination of LIZZY'S GIRL revealed that the greyhound sustained cramp in both hindlegs. Stewards spoke to trainer Nicole Howard regarding the greyhound's actions shortly after turning into the home straight. After viewing the patrol footage, it was agreed that LIZZY'S GIRL visibly eased and failed to pursue the lure at that stage of the race. Consequently, under the provisions of GAR 125 the greyhound will be stood down for a period of 5-days and must complete a satisfactory trial before being permitted to race again for failing to pursue the lure by reason of injury.
