Any references to the "Tasracing Integrity Unit", "Integrity Unit", "TIU" or "Tasracing" within this document means "Tasracing Pty Ltd".

The Tasracing Integrity Unit (TIU) may grant any licence for such period and upon such conditions as deemed fit. Any licence may be suspended, cancelled, or refused by the Tasracing Integrity Unit.

Applicants **MUST** note:

- The standard processing timeframe is **7-10 working days** for correctly submitted applications unless the applicant is required to be interviewed by the Tasracing Integrity Unit Licensing Panel, which may increase the processing timeframe.
- Lodging an application form and paying the applicable fee **does not** mean applicants are licensed from that time.
- Applications must be approved and processed by the Tasracing Integrity Unit (TIU) before a licence becomes active. The TIU will notify applicant in writing following approval or denial of their application.

How can I have my application processed as quickly as possible?

Completed applications are processed quicker than those requiring additional information. Before applying, please make sure:

- all sections of the form have been completed;
- all signatures are included;
- supporting documentation is attached (where requested);
- payment details for the application fee (if applicable) is provided with the application; and
- when requested by the TIU to have a photo taken, you attend to this immediately.
- Requests for additional information may delay the assessment of the application.

How long will it take to process my application?

New Application

The TIU receives licence applications daily, which are processed in the order they are received. Processing timeframes vary depending on the type of application and whether additional information is required. The Operations team at the TIU will endeavour to give you an idea of the processing timeframe for your application should you request it.

Licence Renewals

The TIU commits to ensuring that ALL fully completed applications received by the closing date will be processed in time for the applicant to be relicensed for the following season. Applications received after the closing date will be processed in the order they are received and may result in applicants being unlicensed for the beginning of the new season.

Your responsibilities

The TIU makes every endeavour to provide a high level of service to participants. To assist us in delivering this level of service please ensure that:

- all interactions between staff and customers occur in a courteous manner;
- staff are treated politely and respectfully;
- all available relevant information is provided; and
- interactions with staff occurs in a co-operative and positive manner.

The TIU has a zero tolerance policy of inappropriate behaviour towards its staff. Licensed industry participants engaging in such behaviour will be referred to stewards who will take appropriate action under the rules of racing.

General information applicable to ALL licence categories

The below listed Tasracing Licensing Requirements **MUST** be read carefully prior to completing an application for a licence.

1. Rules of Racing –

All applicants applying for a licence should obtain a copy of the Rules of Racing.

2. National Police Record Check (NPRC)

For persons over the age of eighteen (18) years a current National Police Record Check must accompany an application for licence if:

- a. Applying to be licensed in any category if not provided within two (2) years of the date of the application.
- b. The applicant is returning from a period of disqualification and has not provided a police check within two (2) years of the date of the application.
- c. Requested by the TIU with reasonable cause. Reasons could include to obtain further detail of information provided previously; outcome of previously pending criminal charges; information submitted with an application to renew a licence.
- d. For licence renewals every three (3) years.

Applicants who are required to submit a National Police Record Check may be issued a temporary licence for three months prior to lodgement of the police check report if :

- o All other requirements for the licence category have been submitted to the TIU.
- o A copy of the receipt for payment of the NPRC application is provided with the licence application.
- o Information provided on the application form does not indicate matters on which the TIU may require further details prior to the determination of the application.

NB: A National Police Record Check is deemed current if it has a date of issue no more than 3 months prior to the date that it is lodged with the TIU.

The National Police Record Check must be obtained via Service Tasmania. - [Apply for a national police record check | Service Tasmania](#)

3. Working with Vulnerable People

For any participant employing or working directly with a person under the age of eighteen (18) years a current Working with Vulnerable People Card must accompany an application or renewal.

The Working with Vulnerable People registration must be obtained via Service Tasmania - [Apply for registration to work with vulnerable people | Service Tasmania](#)

4. Evidence of Identity

Applicants must provide evidence of identity by submitting a copy of one of the following documents:

- Birth certificate;
- Current driver's licence; or
- Current passport

5. Mandatory Training Requirements

To obtain and/or maintain a licence of any category, participants must comply with any training requirements as mandated by Tasracing from time to time. For information on current training requirements for any licence category, please contact Tasracing via email to racing_team@tasracing.com.au or phone (03) 6212 9333. All licensed persons must attend any workshops mandated by Tasracing as compulsory.

Definition of "New Applicant" for Mandatory Training purposes

A new applicant is defined as somebody who has never been previously licensed in Tasmania in the greyhound racing code. New applicants will be provided adequate time to complete any training, commencing from the date that their licence is approved by the TIU.

- Attendant – 3 months
- Trainer – 12 months

6. Public Trainers

Persons licensed in this category are advised that a period of inactivity of more than five (5) years may result in an interview with the TIU to show cause why this level of licence should be retained.

7. International Applicants

Applicants who are not the holders of Australian citizenship must provide the following with their application in addition to the requirements of a licence:

- Copy of passport.
- Copy of Visa which indicates permission to work in Australia.
- Clearance from the International Controlling Body where **last** licensed, which shows
 - the licence/s held;
 - offence history;
 - If applying for a trainer's licence a performance record including number of winners.

8. Applicant Knowledge and Experience

The Tasracing Integrity Unit may, on application and at their absolute discretion, vary the requirements of the knowledge and/or experience required for any licence category should they be satisfied that the applicant has sufficient knowledge and/or experience to be granted a licence of that category.

9. Suitability of Licence Holders

In determining whether an applicant or licence holder is suitable to hold a licence, registration or other approval within the Tasmanian racing industry, Tasracing may consider any matter it considers relevant to the person's fitness, propriety, integrity, character, competence and ability to comply with the regulatory requirements of the industry.

A person may be determined unsuitable to hold a licence where Tasracing is not satisfied that the person is a "fit" and "proper" person.

Without limitation, Tasracing may have regard to the following matters:

a) Fitness and Capability

Whether the applicant or licence holder:

- i. is physically and mentally capable of performing the duties and responsibilities of the relevant licence category;
- ii. possesses the skills, knowledge, experience and competency required for the relevant licence category;
- iii. has demonstrated the capacity to make appropriate decisions and conduct themselves in a manner consistent with the integrity and reputation of the Tasmanian racing industry;
- iv. has sufficient financial resources or financial capacity to fulfil the obligations associated with the licence.

Tasracing may require an applicant or licence holder to provide evidence of fitness, competency, qualifications, financial capacity, training or assessment outcomes.

b) Full and Frank Disclosure

Whether the applicant or licence holder has made full and frank disclosure of all matters required by Tasracing in any application, interview, investigation, inquiry or other disclosure process.

c) Compliance History

Whether the applicant or licence holder has demonstrated compliance with:

- i. the Rules of Racing, policies, standards, directions and regulatory requirements of Tasracing or any other racing authority;
- ii. the regulatory requirements of any other sporting body or industry in which the person has participated or been involved;
- iii. applicable animal welfare standards, policies and guidelines;
- iv. any applicable legislation, regulations or lawful directions.

d) Integrity, Conduct and Reputation

The person's:

- i. history, reputation, integrity, honesty and character;
- ii. conduct towards Tasracing, Clubs, officials, employees, licensed persons and animals;
- iii. behaviour or statements that may adversely affect public confidence in, or the reputation of, the Tasmanian racing industry;
- iv. ability to consistently comply with the Rules of Racing, Tasracing policies and applicable laws.

e) Disciplinary and Regulatory Matters

Any:

- i. disciplinary action, inquiry, suspension, disqualification or adverse finding made by Tasracing, another racing authority, sporting body, tribunal or regulatory authority;
- ii. previous breaches of the Rules of Racing or other regulatory requirements;
- iii. exclusion, warning-off order or similar restriction imposed by any racing or regulatory authority.

f) Criminal and Civil Matters

Details of:

- i. any criminal conviction in Australia or any other jurisdiction;
- ii. any pending criminal charge or criminal proceeding;
- iii. any conviction or proceeding relating to dishonesty, fraud, forgery, assault, match-fixing, corruption, animal welfare, animal cruelty, trafficking or supply of drugs or prohibited substances;
- iv. any sexual offence involving a child;
- v. any parole, bail or community corrections order;
- vi. any exclusion order made by a Commissioner of Police or equivalent authority;
- vii. any adverse finding by a court, tribunal or regulatory body in civil, disciplinary or regulatory proceedings relevant to the person's suitability.

Tasracing may require an applicant or licence holder to provide a current National Police Check or other information relevant to assessing suitability.

g) Employment and Behavioural Matters

Whether the applicant or licence holder has:

- i. been dismissed, asked to resign, or resigned from employment or a position of trust due to dishonesty, fraud, integrity concerns or misconduct;
- ii. engaged in inappropriate, violent, threatening or abusive behaviour;
- iii. engaged in conduct involving drugs, alcohol or other behavioural concerns impacting suitability.

h) Financial and Business Matters

Whether the applicant or licence holder:

- i. has been a director, partner or involved in the management of a business subject to insolvency, liquidation or administration;
- ii. has failed to demonstrate adequate financial means to fulfil the obligations of the licence; has financial, personal or business circumstances that may expose the person to improper influence, corruption or conflicts of interest.

i) Welfare, Safety and Industry Integrity

Whether the applicant or licence holder has engaged in conduct, or there are circumstances, which may:

- i. impair their ability to safeguard the welfare of horses, greyhounds or participants;
- ii. pose a risk to the safety, welfare or wellbeing of participants or animals;
- iii. undermine the integrity, reputation or public confidence in the Tasmanian racing industry.

Tasracing may also consider the character, reputation and conduct of persons with whom the applicant or licence holder is associated in personal, professional or business dealings where relevant to the integrity of the racing industry.

j) General Discretion

Tasracing may consider any other matter it considers relevant to determining whether a person is suitable to hold a licence, registration or approval within the Tasmanian racing industry.

A person may be refused, suspended, cancelled or otherwise restricted from holding a licence where Tasracing is not satisfied the person is suitable having regard to the matters set out above.

10. Personal Information Protection Statement

By completing and submitting this document you will be providing personal information to Tasracing Pty Ltd (Tasracing).

Tasracing will manage personal information you provide to it in accordance with the Personal Information Protection Act 2004 (Tas), other relevant laws which apply to Tasracing from time to time, and Tasracing's Privacy Policy.

Your personal information may be disclosed to third parties where it is permitted by law (or otherwise with your consent), including law enforcement agencies, courts and other organisations which are authorised to collect it.

For the avoidance of doubt and without limiting Tasracing's rights to otherwise lawfully disclose information, you expressly acknowledge and agree that your personal information may be disclosed to, and used and disclosed for their purposes by, the Tasmanian Racing Integrity Commissioner, the Racing Integrity Committee, officers appointed under section 13 of the Animal Welfare Act 1993 (Tas) and authorised officers within the meaning of the Biosecurity Act 2019 (Tas) in the discharge of their duties, including for purposes in connection with the Racing Regulation and Integrity Act 2024 (Tas).

Where you provide personal information which is "basic personal information" this may be disclosed to other public sector bodies where necessary, for the efficient storage and use of that information.

The personal information you provide in connection with this document will be used by Tasracing for the purpose of processing your application for a licence and/or registration and for associated purposes pursuant to the Racing Regulation and Integrity Act 2024 (Tas), associated legislation, and the Rules of Racing as adopted by Tasracing from time to time.

If you do not provide to Tasracing the personal information requested by this document the main consequences for you is likely to be that Tasracing may not be able to process your application and/or your application may be considered invalid.

You have the right to access your personal information by request to Tasracing and you may be charged a fee for this service. If you consider any of the personal information held by Tasracing to be incorrect or not up-to-date, please contact Tasracing.

Licensing Procedures

The Tasracing Integrity Unit Licensing Panel considers all licence and registration applications. The Licensing Panel members may include the Chief Racing Integrity Officer, Chief Steward, and/or a member of the Stewards' department and an Operations team representative. The Licensing Panel reserves the right to interview, in person, any person applying for either an initial licence or renewal.

The Tasracing Integrity Unit (TIU) also reserves the right to interview:

- Any licensed or registered person at any time who has been convicted in a court of law of an indictable or summary offence that, in the opinion of the TIU, may prejudice the image of racing; or
- A person who has been charged and found guilty by the Stewards of any offence that, in the opinion of the TIU, may be detrimental to the image of racing; or
- Any licensed or registered person, upon the recommendation of a Steward or an Operations Officer
- Any licensed or registered person, at any time if the TIU becomes aware of matters which may prejudice the image of racing, are welfare related or no longer meets the requirements of a fit and proper person.
- Any person, applying for a licence or registration following the completion of a period of disqualification and that person may be required to appear in person.

New Applicant Definition

- A person who is applying for a licence of any category or registration in Tasmania for the first time; or
- A person who has been licensed or registered previously in the greyhound code but not in the preceding season.

Renewal Definition

- A person who was licensed or registered with the same category of licence or registration in the preceding racing season.

Licensing Guidelines

The following guidelines should be viewed generally with each applicant being assessed on their individual merits with the Tasracing Integrity Unit Licensing Panel reserving the right to have any person appear for interview.

New Applicant

Trainers	First time applicants or persons applying for upgrades will be interviewed by the Licensing Panel.
Owners	To be approved by the TIU via a Chairman's Book.
Owner/Attendant	To be approved by the TIU via a Chairman's Book.
Attendants	To be approved by the TIU via a Chairman's Book.
Catchers	To be approved by the TIU via a Chairman's Book.
Breeders, Rearers & Whelpers	To be approved by the TIU via a Chairman's Book.
Renewals	All categories to be approved by the TIU via a Chairman's Book.
Interstate Applicants	Each interstate applicant will be assessed on their merits given the licence held and experience obtained through the appropriate jurisdiction where the individual has been licensed.

Licence applications may be referred to the Racing Integrity Committee for feedback if deemed necessary after the Licensing Panel interview has been conducted.

Licensing Review Guidelines

All licences are subject to review at any time but, at least on an annual basis. Relevant matters for the Tasracing Integrity Unit to consider include:

- (a) If the participant has been found guilty of breaches of the Rules of Racing on multiple occasions;
- (b) If a greyhound that the participant is responsible for is not presented in a way public confidence can be guaranteed;
- (c) If the participant engages in actions that are detrimental to the image of the industry and public perception;
- (d) If the participant fails to meet a level of activity commensurate with the licence category; or
- (e) If the participant no longer meets the requirements of a “fit” and “proper” person.

The Tasracing Integrity Unit may issue a show cause notice on any participant, who is deemed not to meet the guidelines, as to why they should retain their licence.

Renewals

All licence renewals are issued at the discretion of the Tasracing Integrity Unit to a person who has lodged a completed renewal application form accompanied with the prescribed fee and any other required documentation. Renewal applications are reviewed by the Operations team and the Chairman of Stewards before being presented to the Chief Racing Integrity Officer.

The above Licensing Procedures refer to all licences, whether they are a new application, an upgrade, or a renewal.

Registration Categories

Partnership

Fee: N/A

A *Partnership* is a minimum of two (2) and a maximum of four (4) persons. All persons in a partnership must be licensed as either an owner, owner/attendant, trainer public or owner/trainer.

Private Syndicate Registration

Fee: \$110.00

Private Syndicates are a group of at least two (2) licensed persons but no more than 20 registered persons who may own and race a greyhound in a name other than the names of the syndicate members.

A *Syndicate* registration is issued at the discretion of the Tasracing Integrity Unit to a group of persons who have:

- Lodged a completed application form accompanied with the prescribed fee.
- Nominated a Syndicate Manager and Alternative Syndicate Manager who must both be licensed as either an owner, owner/attendant, trainer public or owner/trainer.
- **All** syndicate members who do not hold a licence with owner privileges, will be registered as stipulated for a Syndicate Member. NB: Persons registered as such may only own a greyhound as part of the currently registered syndicate.

Public Syndicate Registration

Fee: \$210.00

Public Syndicates must not have any more than fifty (50) Members and must be registered with ASIC and the Controlling Body before advertising, offering, or selling any shares. NB: Members of a Public Syndicate are not required to be registered as owners under the Rules.

A *Public Syndicate* registration is issued at the discretion of the Tasracing Integrity Unit to a group of persons who have:

- Lodged a completed application form accompanied with the prescribed fee.
- Lodged all documentation as required under Local Rule 46B.19 together with evidence of ASIC registration.
- Nominated a Syndicate Manager and Alternative Syndicate Manager who are empowered to sign and execute documents on behalf of a Public Syndicate and must maintain all records as required under Local Rule 46B.16. These persons must hold a licence with owner privileges.

Syndicate Member

Fee: No Fee

The holder of a *Syndicate Member* registration may only own greyhounds as part of a registered private syndicate.

A *Syndicate Member's* registration is issued at the discretion of the Tasracing Integrity Unit to a person who has:

- Attained the age of eighteen (18) years.
- Provided personal details as required on a Private Syndicate Application Form as approved by the Tasracing Integrity Unit.

Licence Categories

Owner

Fee: Tasracing subsidised

The holder of an *Owner Licence* may own greyhounds or be a manager or member of a syndicate. The licence holder is not permitted to catch, handle, parade, kennel or train greyhounds at any registered racetrack, trial track or licensed trainer's property.

An *Owner licence* is issued at the discretion of the Tasracing Integrity Unit to a person who has:

- Attained the age of eighteen (18) years.
- Lodged a completed application form with the prescribed fee.
- Submitted a current National Police Record Check if required. (*Refer to Clause 2*)
- If not previously submitted, provided evidence of identity. (*Refer to Clause 4*)

NB: An Owner licence will be for a period of five (5) years with an expiry date of 31 July in the relevant year.

Breeder/Whelpers/Rearer

Fee: Tasracing subsidised

The managing owner of any registered female greyhound to be used for breeding purposes, or person with an authority (Form B) to breed a litter from a registered female greyhound, or a person engaged by the breeder who has the day-to-day care, control and custody of a female greyhound used for breeding or the rearing of greyhound pups, must hold the relevant licence to undertake the particular activity.

Definitions:

Breeder – The managing owner of a registered female greyhound who can apply for her registration as a Breeding Female and arrange for the service or artificial insemination. A breeder is also entitled to whelp, rear and pre- educate the litter of greyhound pups.

Whelpers – A person engaged by the breeder to have the day-to-day care, control and custody of the Breeding Female including whelping, care, and custody of her litter until the pups have been vaccinated, and microchipped (maximum period of 16 weeks).

Rearer – A person who takes possession and thereby assumes responsibility for a greyhound pup for the purpose of rearing and education, from the time the pup has been vaccinated, and microchipped until such time as the greyhound is transferred to a trainer's racing kennel.

Any **new applicant** who can demonstrate sufficient breeding knowledge and experience with animals other than greyhounds, can apply to be recognised as a **breeder, whelper** or **rearer**. The application will be reviewed by the Tasracing Integrity Unit and the Regulatory Veterinarian who will have absolute discretion in determining if the application is to be approved.

Applicants should also read the Greyhound Breeder Licensing Fact Sheet on the TIU website - www.tasracingintegrity.com.au

A *Breeder, Whelper* or *Rearer* licence is issued at the discretion of the Tasracing Integrity Unit to a person who has:-

- **For a Breeder licence**, a current licence with ownership privileges in the greyhound industry in Tasmania.
- Attained the age of eighteen (18) years.
- Completed and lodged the relevant application form with the prescribed fee (if a fee is applicable).
- If not previously submitted, provided evidence of identity. (*Refer to Page 5*)
- Submitted a current National Police Record Check if required. (*Refer to Page 5*)
- Submitted and successfully completed the Breeder's Education Package Questionnaire Units required for the activities to be conducted.
- A suitable property for the breeding and housing of greyhounds.
- Had a satisfactory inspection of their property by Stewards once the application is of an appropriate level for approval by the TIU.
- Met all relevant local government (Council) and state government regulations and can provide evidence if requested.

NB: Persons who intend applying for a licence as a Whelper or Rearer are not required to hold a current licence with ownership privileges unless they intend to be involved in the greyhound industry in another capacity.

CATCHER

Catcher (12 & 13 year old ONLY)

Fee: No Fee

A *Catcher* registration allows a 12 or 13 year old person to catch and box greyhounds at trials only at a registered track. These catchers must be directly supervised by an adult (18yo+) who holds a current full adult registration with the Tasracing Integrity Unit. **This registration will not allow you to perform any roles at a race meeting.**

A *Catcher* licence is issued at the discretion of the Tasracing Integrity Unit to a person who has:

- Attained the age of 12 or 13 years. (*Written parental consent is required*)
- Lodged a completed application form.
- Provided evidence of identity which confirms age. (*Refer to Page 5*)
- Provided a supervision and instruction agreement completed by a person who holds a full adult registration with the TIU.
- Once issued with a Photo Letter of Authority by the TIU, attend a Service Tasmania outlet and have their photo taken to allow the issue of a registration card.

ATTENDANTS

Attendant (Handler) - Provisional

Fee: See Fee Schedule

The holder of an *Attendant Provisional* licence may catch any greyhound at **trials only** and may handle, parade, or kennel any greyhound at any race meeting under the supervision of a nominated licensed Trainer.

An *Attendant Provisional* licence is issued at the discretion of the Tasracing Integrity Unit to a person who has:

- Attained the age of fourteen (14) years.
(*Written parental consent is required if under eighteen (18) years of age*)
- Lodged a completed application form with the prescribed fee.
- If not already submitted, provided evidence of identity. (*Refer to Page 5*)
- For persons over eighteen (18) years of age, submitted a current National Police Record Check if required. (*Refer to Clause 2*)
- For persons working with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Clause 3*)
- Provided a supervision and instruction agreement completed by a person who holds a Trainer's registration with the TIU.

Attendant (Handler)

Fee: See Fee Schedule

The holder of an *Attendant* licence may catch, handle and parade or kennel any greyhounds at trials or race meetings.

An *Attendant* licence is issued at the discretion of the Tasracing Integrity Unit to a person who has:

- Attained the age of fourteen (14) years.
(*Written parental consent is required if under eighteen (18) years of age*)
- Lodged a completed application form with the prescribed fee.
- If not already submitted, provided evidence of identity. (*Refer to Page 5*)
- For persons over eighteen (18) years of age, submitted a current National Police Record Check if required (*Refer to Clause 2*)
- For persons working with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Clause 3*)
- Satisfactorily completed the Attendant Questionnaire, if not already completed (catching and handling duties).
- Completed the mandatory training and submitted evidence of completion within twelve (12) months or within such other time limits imposed.
- Undertaken catching at trial meetings for a period of at least one (1) month and during that time caught a minimum of twenty (20) greyhounds. (**NB: This is not required if the applicant has held a 12 or 13 year old Catcher licence**)

- Lodged an activity record sheet completed by the trainer they have been working for attesting to their ability to undertake this role including the number of occasions the person has carried out the duties of a catcher at trials.

To be granted permission to be an attendant to handle, kennel or parade a greyhound at race meetings without supervision from a trainer, applicants must –

- Carry out attendant activities at race meetings under the supervision of a nominated licensed trainer on at least six (6) occasions.
- Lodge an activity record sheet completed by the trainer they have been working for attesting to their ability to undertake this role including the number of occasions the person has carried out the duties of a handler at race meetings.

NB: Consideration will be given to experience gained if the applicant has been previously licensed in this category or higher and evidence of such registration can be confirmed by the TIU, to allow the waiving of the provisional supervisory requirements.

Owner/Attendant

Fee: See Fee Schedule

The holder of an *Owner/Attendant* licence may own greyhounds; be a manager or member of a syndicate; catch and/or handle and parade or kennel any greyhounds at trials or race meetings. The licence holder is not permitted to train greyhounds.

An *Owner/Attendant* licence is issued at the discretion of the Tasracing Integrity Unit to a person who has:

- Attained the age of eighteen (18) years.
- Lodged a completed application form with the prescribed fee.
- If not previously submitted, provided evidence of identity. (*Refer to Clause 4*)
- Submitted a current National Police Record Check if required. (*Refer to Clause 2*)
- For persons working with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Clause 3*)
- Satisfactorily completed the Owner/Attendant Questionnaire, if not already completed.
- Completed the mandatory training and submitted evidence of completion within twelve (12) months or within such other time limits imposed.
- Undertaken catching at trial meetings for a period of at least one (1) month and during that time caught a minimum of twenty (20) greyhounds
- Lodged an activity record sheet completed by the trainer they have been working for attesting to their ability to undertake this role including the number of occasions the person has carried out the duties of a catcher at trials.

To be granted permission to be an attendant to handle, kennel or parade a greyhound at race meetings **without supervision** from a trainer, applicants must –

- Carry out attendant activities at race meetings under the supervision of a nominated licensed trainer on at least six (6) occasions.
- Lodge an activity record sheet completed by the trainer they have been working for attesting to their ability to undertake this role including the number of occasions the person has carried out the duties of a handler at race meetings.

TRAINERS

Owner/Trainer

Fee: See Fee Schedule

The holder of an *Owner/Trainer* licence may, train greyhounds that are owned or part owned by themselves or by the person's spouse, other domestic partner, parent, sibling, or child; nominate and scratch greyhounds trained by them; be the registered owner or part owner of any greyhound; be a manager or a member of a syndicate; catch, handle, parade or kennel any greyhounds at trials or race meetings.

Persons must meet the following pre-requisites to have an application for this category of licence considered:

- Currently hold an Attendant or Owner-Attendant licence and have held that licence for not less than 6 months; or
- Currently hold an equivalent licence in another code of racing and have held that licence for a period of at least one (1) year.

OR – if the applicant does not currently hold a licence as stated above:

- Previously have held (with any Controlling Body), a greyhound owner-trainer licence (or its equivalent or higher level) and have been licensed as such within three (3) years from the date that an application is submitted to the Tasracing Integrity Unit.

An *Owner/Trainer* licence is issued at the discretion of the Tasracing Integrity Unit to a person who meets the above pre-requisites and who:

- Has attained the age of eighteen (18) years.
- Has lodged a completed application form with the prescribed fee
- If not previously submitted, has provided evidence of identity. (*Refer to Clause 4*)
- Has submitted a current National Police Record Check if required. (*Refer to Clause 2*)
- For persons employing or working with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Clause 3*)
- New applicants: Has Submitted an acknowledgement of sufficient financial resources to maintain the welfare of greyhounds.
- Renewals: provided financial statements for the preceding six (6) months if requested by the TIU.
- Ensures that in carrying out activities under this licence they comply with any requirements imposed upon them under the *Workers Rehabilitation and Compensation Act 1988 (WRCA)* from time to time and furnish to Tasracing a certificate of currency of insurance for the purposes of the WRCA within seven (7) days of being requested to do so by Tasracing.
- Ensures that in carrying out activities under this licence they only carry out those activities on land on which they may lawfully do so under the *Land Use Planning and Approvals Act 1993* and in doing so comply with the requirements of any authority having statutory or regulatory jurisdiction over that land
- For new applications, submitted a copy of Local Council Kennel Licence/Registration for applicants who have more than two (2) greyhounds at any one address.
- For licence renewal, met all local government (Council) and state government regulations and be able to provide evidence of same if requested by a TIU Steward or authorised person.
- Satisfactorily completed the Trainer Questionnaire.
- Submitted one (1) written reference from a currently licensed Trainer.
- Completed the mandatory training and submitted evidence of completion or equivalent as approved by Tasracing within twelve (12) months or within such other time limits imposed.
- Suitable kennels for the management and housing of greyhounds.
- Had a successful interview with the Tasracing Integrity Unit.
- Had their kennels inspected to the satisfaction of Stewards once the application is of an appropriate level for approval by the Tasracing Integrity Unit.

The holder of a *Trainer Public* licence may train greyhounds owned by them and/or any registered owner; nominate and scratch any greyhounds trained by them; be the registered owner or part owner of any greyhound; be a manager or a member of a syndicate, catch, handle, parade or kennel any greyhound at trials or race meetings.

Persons must meet the following pre-requisites to have an application for this category of licence considered:

- Currently hold an Owner-Trainer licence and have held that licence for not less than twelve (12) months; or
- Currently hold an equivalent licence in another code of racing and have held that licence for a period of at least two (2) years.

OR – if the applicant does not currently hold a licence as stated above

- Previously have held (with any Controlling Body), a Trainer Public licence (or its equivalent or higher level) and been licensed as such within three (3) years from the date that an application is submitted to the Tasracing Integrity Unit.

A Trainer Public licence is issued at the discretion of the Tasracing Integrity Unit to a person who meets the above pre-requisites and:

- Has attained the age of eighteen (18) years.
- Has lodged a completed application form with the prescribed fee.
- If not previously submitted, has provided evidence of identity. (*Refer to Clause 4*)
- Has submitted a current National Police Record Check if required. (*Refer to Clause 2*)
- For persons employing or working with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Clause 3*)
- New applicants: Has submitted an acknowledgement of sufficient financial resources to maintain the welfare of greyhounds.
- Renewals: provided financial statements for the preceding six (6) months if requested by the TIU.
- Ensures that in carrying out activities under this licence they comply with any requirements imposed upon them under the *Workers Rehabilitation and Compensation Act 1988 (WRCA)* from time to time and furnish to Tasracing a certificate of currency of insurance for the purposes of the WRCA within seven (7) days of being requested to do so by Tasracing.
- Ensures that in carrying out activities under this licence they only carry out those activities on land on which they may lawfully do so under the *Land Use Planning and Approvals Act 1993* and in doing so comply with the requirements of any authority having statutory or regulatory jurisdiction over that land
- For new applications, submitted a copy of Local Council Kennel Licence/Registration for applicants who have more than two (2) greyhounds at any one address.
- For licence renewal, met all local government (Council) and state government regulations and be able to provide evidence of same if requested by a TIU Steward or authorised person.
- If not currently licensed as a trainer, submitted one (1) written reference from a currently licensed Trainer Public.
- Completed the mandatory training and submitted evidence of completion or equivalent as approved by Tasracing within twelve (12) months or within other time limits imposed.
- Suitable kennels for the management and housing of greyhounds.
- Had a successful interview with the Tasracing Integrity Unit.
- Had their kennels inspected to the satisfaction of Stewards once the application is of an appropriate level for approval by the Tasracing Integrity Unit.
