In the opinion of Stewards, RHINESTONE marred the running of ROMFORD on two occasions, firstly on the turn off the back straight, and again when in the home straight, when the greyhound turned its head, and made head and muzzle contact with the other runner. As this was the greyhound's first offence, RHINESTONE will be stood down from racing for a period of 28 days at Launceston only, and until completion of a satisfactory stewards trial.
