## Notification/Change of Bank Details

### GST INFORMATION & DECLARATION

By completing and signing this form I notify and declare that I am registered for GST or an ABN or Hobbyist, as shown hereon. I will notify the State Controlling Body if I cease to be registered for GST or for an ABN.

In signing this form I acknowledge that information contained in this document may be passed to controlling bodies in other States to facilitate payment of prize money or use of the declared ABN.

*You are not entitled to an ABN if your activity is a private or recreational pursuit or hobby.*

*If your horse racing activities constitute a business and the enterprise is registered for goods and services tax (GST) you can quote the ABN of the enterprise to this racing authority.*

**Many people own racing horses and also run other enterprises, which are not connected with the racing industry. Generally the horse racing activities of these people are conducted as a private or recreational pursuit or hobby. EG – An owner who runs his own carpentry business, cake shop or hotel cannot use that business' ABN for their hobby racing activities. If you are unsure, you should contact the Australian Tax Office.**

### HOBBYIST DECLARATION

If you have indicated that you are a "Hobbyist", you are confirming that you are a Genuine Hobbyist who is not able to claim a credit for GST paid on your Harness Racing purchases. If you wish to be able to claim back GST that you pay on your purchases, you should register for GST with an Australian Business Number (ABN).

1. I participate in harness racing as an owner/entity-owner "not considered to be carrying on an enterprise", but as a hobby or recreational pursuit.
2. I understand that under the Tax System if I am "not considered to be carrying on an enterprise", but as a hobbyist participant in harness racing, *I will NOT be able to claim an input tax credit ("refund") for Goods and Services Tax* that I pay on my purchases.
3. I declare that my supply of horses for harness racing is an activity done as a private recreational pursuit or hobby or is wholly of a private or domestic nature for me.
4. I declare that my involvement in harness racing is undertaken without reasonable expectation of a profit. I will not be making a taxation deduction for any expenses associated with my involvement with harness racing.
5. Should any of these circumstances change I will advise the controlling body for harness racing in our State immediately.
6. The details on page 1 of this document are true and correct.

If you do not provide to Tasracing the personal information requested by this document the main consequences for you is likely to be that Tasracing may not be able to process your application and/or your application may be considered invalid.
