Any references to the "Tasracing Integrity Unit", "Integrity Unit", "TIU" or "Tasracing" within this document means "Tasracing Pty Ltd".

The Tasracing Integrity Unit (TIU) may grant any licence for such period and upon such conditions as deemed fit. Any licence may be suspended, cancelled, or refused by the Tasracing Integrity Unit.

Applicants MUST note:

- Standard processing timeframe is **7-10 working days** for correctly submitted applications, unless the applicant is required to be interviewed by the Tasracing Integrity Unit, which may increase the processing timeframe.
- Lodging an application form and paying the applicable fee **does not** mean that applicants are licensed from that time.
- Applications must be approved by the Tasracing Integrity Unit (TIU) before a licence becomes active. The TIU will notify applicants in writing following approval or denial of their application.

How can I have my application processed as quickly as possible?

Completed applications are processed quicker than those requiring additional information. Before submitting an application, please make sure:

- all sections of the form have been completed;
- all signatures are included;
- supporting documentation is attached (where requested);
- payment of the application fee (if applicable) is provided with the application;
- when requested by the TIU to have a photo taken, you attend to this immediately;
- requests for additional information may delay the assessment of the application.

How long will it take to process my application?

New Application

The TIU receives licence applications daily, which are processed in the order they are received. Processing timeframes vary depending on the type of application and whether additional information is required. The Operations team at the TIU will endeavour to give you an idea of the processing timeframe for your application should you request it.

Licence Renewals

The TIU commits to ensuring that ALL fully complete applications received by the closing date will be processed in time for the applicant to be relicensed for the following season. Applications received after the closing date will be processed in the order that they are received and may result in applicants being unlicensed for the beginning of the new season.

Your responsibilities

The TIU makes every endeavour to provide a high level of service to participants. To assist us in delivering this level of service please ensure that:

- all interactions between staff and customers occur in a courteous manner;
- staff are treated politely and respectfully;
- all available relevant information is provided; and
- the interaction occurs in a co-operative and positive manner.

The TIU has a zero-tolerance policy of inappropriate behaviour towards its staff. Licensed industry participants engaging in such behaviour will be referred to stewards who will take appropriate action under the rules of racing.

General information applicable to ALL licence categories

The below listed Tasracing Licensing Requirements **MUST** be read carefully prior to completing an application for a licence.

1. **Rules of Racing** – All applicants applying for a licence should obtain a copy of the Rules of Racing.

2. **National Police Record Check (NPRC)**

For persons over the age of eighteen (18) years a current National Police Record Check must accompany an application for licence if:

- a. Applying to be licensed (renewals excepted) in any category of licence if not provided within two (2) years of the date of the application.
- b. The applicant is returning from a period of disqualification and has not provided a police check within two (2) years of the date of the application.
- c. Requested by the TIU with reasonable cause. Reasons could include to obtain further details of information provided previously; outcome of previously pending criminal charges, information submitted with an application to renew a licence.
- d. For licence renewals every three (3) years.

Applicants who are required to submit a National Police Record Check may be issued a temporary licence for three months prior to lodgement of the police check report if:

- All other requirements for the licence category have been submitted to the TIU.
- A copy of the receipt for payment of the NPRC application is provided with the licence application.
- Information provided on the application form does not indicate matters on which the TIU may require further details prior to determination of the application.

NB: A National Police Record Check is deemed current if it has a date of issue no more than 3 months prior to the date that it is lodged with the TIU.

The National Police Record Check must be obtained via Service Tasmania. - [Apply for a national police record check | Service Tasmania](#)

3. **Working with Vulnerable People**

For any participant employing or working directly with a person under the age of eighteen (18) years a current Working with Vulnerable People Card must accompany an application or renewal.

The Working with Vulnerable People registration must be obtained via Service Tasmania - [Apply for registration to work with vulnerable people | Service Tasmania](#)

4. **Visiting Interstate Trainer Licence Information**

Please refer to AR 109 and information for requirements regarding this licence is available at www.tasracing.com.au/integrity

5. **Evidence of Identity**

Applicants must provide evidence of identity by submitting a copy of one of the following documents:

- Birth certificate;
- Current driver's licence; or
- Current passport

6. **Mandatory Training Requirements**

To obtain and/or maintain a licence of any category, participants must comply with any training requirements as mandated by Tasracing from time to time. For information on current training requirements for any licence category, please contact Tasracing via email at racinq_team@tasracing.com.au or phone (03) 6212 9333.

All licensed persons must attend any workshops mandated by Tasracing as compulsory.

Definition of "New Applicant" for Mandatory Training purposes

A new applicant is defined as somebody who has never been previously licensed in the thoroughbred racing code. New applicants will be provided adequate time to complete any training, commencing from the date that their licence is approved by the TIU:

- Stablehand – 3 months
- Trackwork Rider – 6 months
- Trainer – 12 months

7. Interstate Stable Employee & Trackwork Rider Licence Holders

Please refer to Local Rules 19.1(c), 19.2(e) & 19.3 for requirements regarding these licences.

8. International Applicants

Applicants who are not the holders of Australian citizenship must provide the following with their application in addition to the other requirements of a licence:

- Copy of passport.
- Copy of Visa which indicates permission to work in Australia.
- Clearance from the International Controlling Body where **last** licensed, which shows
 - the licence/s held;
 - offence history;
 - If applying for riding licence, performance record including number of winning rides.
- Full medical examination report showing appropriate fitness to ride, issued by an Australian Registered Medical Practitioner (if necessary for particular licence).
- A Baseline Concussion Test (if necessary for particular licence) may be required if deemed appropriate by the Tasracing Integrity Unit at the time of applicant's arrival in Tasmania.

9. Applicant Knowledge and Experience

The Tasracing Integrity Unit may, on application and at their absolute discretion, vary the requirements of the knowledge and/or experience required for any licence category should they be satisfied that the applicant has sufficient knowledge and/or experience to be granted a licence of that category.

10. Suitability of Licence Holders

In determining whether an applicant or licence holder is suitable to hold a licence, registration or other approval within the Tasmanian racing industry, Tasracing may consider any matter it considers relevant to the person's fitness, propriety, integrity, character, competence and ability to comply with the regulatory requirements of the industry.

A person may be determined unsuitable to hold a licence where Tasracing is not satisfied that the person is a "fit" and "proper" person.

Without limitation, Tasracing may have regard to the following matters:

a) Fitness and Capability

Whether the applicant or licence holder:

- i. is physically and mentally capable of performing the duties and responsibilities of the relevant licence category;
- ii. possesses the skills, knowledge, experience and competency required for the relevant licence category;
- iii. has demonstrated the capacity to make appropriate decisions and conduct themselves in a manner consistent with the integrity and reputation of the Tasmanian racing industry;
- iv. has sufficient financial resources or financial capacity to fulfil the obligations associated with the licence.

Tasracing may require an applicant or licence holder to provide evidence of fitness, competency, qualifications, financial capacity, training or assessment outcomes.

b) Full and Frank Disclosure

Whether the applicant or licence holder has made full and frank disclosure of all matters required by Tasracing in any application, interview, investigation, inquiry or other disclosure process.

c) Compliance History

Whether the applicant or licence holder has demonstrated compliance with:

- i. the Rules of Racing, policies, standards, directions and regulatory requirements of Tasracing or any other racing authority;
- ii. the regulatory requirements of any other sporting body or industry in which the person has participated or been involved;
- iii. applicable animal welfare standards, policies and guidelines;
- iv. any applicable legislation, regulations or lawful directions.

d) Integrity, Conduct and Reputation

The person's:

- i. history, reputation, integrity, honesty and character;
- ii. conduct towards Tasracing, Clubs, officials, employees, licensed persons and animals;
- iii. behaviour or statements that may adversely affect public confidence in, or the reputation of, the Tasmanian racing industry;
- iv. ability to consistently comply with the Rules of Racing, Tasracing policies and applicable laws.

e) Disciplinary and Regulatory Matters

Any:

- i. disciplinary action, inquiry, suspension, disqualification or adverse finding made by Tasracing, another racing authority, sporting body, tribunal or regulatory authority;
- ii. previous breaches of the Rules of Racing or other regulatory requirements;
- iii. exclusion, warning-off order or similar restriction imposed by any racing or regulatory authority.

f) Criminal and Civil Matters

Details of:

- i. any criminal conviction in Australia or any other jurisdiction;
- ii. any pending criminal charge or criminal proceeding;
- iii. any conviction or proceeding relating to dishonesty, fraud, forgery, assault, match-fixing, corruption, animal welfare, animal cruelty, trafficking or supply of drugs or prohibited substances;
- iv. any sexual offence involving a child;
- v. any parole, bail or community corrections order;
- vi. any exclusion order made by a Commissioner of Police or equivalent authority;
- vii. any adverse finding by a court, tribunal or regulatory body in civil, disciplinary or regulatory proceedings relevant to the person's suitability.

Tasracing may require an applicant or licence holder to provide a current National Police Check or other information relevant to assessing suitability.

g) Employment and Behavioural Matters

Whether the applicant or licence holder has:

- i. been dismissed, asked to resign, or resigned from employment or a position of trust due to dishonesty, fraud, integrity concerns or misconduct;
- ii. engaged in inappropriate, violent, threatening or abusive behaviour;
- iii. engaged in conduct involving drugs, alcohol or other behavioural concerns impacting suitability.

h) Financial and Business Matters

Whether the applicant or licence holder:

- i. has been a director, partner or involved in the management of a business subject to insolvency, liquidation or administration;
- ii. has failed to demonstrate adequate financial means to fulfil the obligations of the licence; has financial, personal or business circumstances that may expose the person to improper influence, corruption or conflicts of interest.

i) Welfare, Safety and Industry Integrity

Whether the applicant or licence holder has engaged in conduct, or there are circumstances, which may:

- i. impair their ability to safeguard the welfare of horses, greyhounds or participants;
- ii. pose a risk to the safety, welfare or wellbeing of participants or animals;
- iii. undermine the integrity, reputation or public confidence in the Tasmanian racing industry.

Tasracing may also consider the character, reputation and conduct of persons with whom the applicant or licence holder is associated in personal, professional or business dealings where relevant to the integrity of the racing industry.

j) General Discretion

Tasracing may consider any other matter it considers relevant to determining whether a person is suitable to hold a licence, registration or approval within the Tasmanian racing industry.

A person may be refused, suspended, cancelled or otherwise restricted from holding a licence where Tasracing is not satisfied the person is suitable having regard to the matters set out above.

11. Personal Information Protection Statement

By completing and submitting this document you will be providing personal information to Tasracing Pty Ltd (**Tasracing**).

Tasracing will manage personal information you provide to it in accordance with the *Personal Information Protection Act 2004* (Tas), other relevant laws which apply to Tasracing from time to time, and Tasracing's Privacy Policy.

Your personal information may be disclosed to third parties where it is permitted by law (or otherwise with your consent), including law enforcement agencies, courts and other organisations which are authorised to collect it.

For the avoidance of doubt and without limiting Tasracing's rights to otherwise lawfully disclose information, you expressly acknowledge and agree that your personal information may be disclosed to, and used and disclosed for their purposes by, the Tasmanian Racing Integrity Commissioner, the Racing Integrity Committee, officers appointed under section 13 of the *Animal Welfare Act 1993* (Tas) and authorised officers within the meaning of the *Biosecurity Act 2019* (Tas) in the discharge of their duties, including for purposes in connection with the *Racing Regulation and Integrity Act 2024* (Tas).

Where you provide personal information which is "basic personal information" this may be disclosed to other public sector bodies where necessary, for the efficient storage and use of that information.

The personal information you provide in connection with this document will be used by Tasracing for the purpose of processing your application for a licence and/or registration and for associated purposes pursuant to the *Racing Regulation and Integrity Act 2024* (Tas), associated legislation, and the Rules of Racing as adopted by Tasracing from time to time.

If you do not provide to Tasracing the personal information requested by this document the main consequences for you is likely to be that Tasracing may not be able to process your application and/or your application may be considered invalid.

You have the right to access your personal information by request to Tasracing and you may be charged a fee for this service. If you consider any of the personal information held by Tasracing to be incorrect or not up-to-date, please contact Tasracing.

Tasracing can be contacted in one of the ways set out on its website (tasracing.com.au), including via phone (03 6212 9333), email (admin@tasracing.com.au) or mail (PO Box 730, Glenorchy TAS 7010).

Licensing Procedures

The Tasracing Integrity Unit Licensing Panel considers all licence applications. The Licensing Panel members may include the Chief Racing Integrity Officer, Chief Steward, and/or a member of the Stewards' department and an Operations team representative. The Licensing Panel reserves the right to interview, in person, any person applying for either an initial licence or renewal.

The Tasracing Integrity Unit (TIU) also reserves the right to interview-

- Any licensed person at any time who has been convicted in a court of law of an indictable or summary offence that, in the opinion of the TIU, may prejudice the image of racing; or
- A person who has been charged and found guilty by the Stewards of any offence that, in the opinion of the TIU, may be detrimental to the image of racing; or
- Any licensed person, upon the recommendation of a Steward or an Operations Officer.
- Any licensed or registered person, at any time if the TIU becomes aware of matters which may prejudice the image of racing, are welfare related or no longer meets the requirements of a fit and proper person.
- Any person applying for a licence or registration following the completion of a period of disqualification and that person may be required to appear in person.

New Applicant Definition

- A person who is applying for a licence of any category in Tasmania for the first time; or
- A person who has been licensed previously in the thoroughbred code but not in the preceding season.

Renewal Definition

- A person who was licensed with the same category of licence in the preceding racing season.

Apprentice Jockey Panel and Riding Review Panel

These Panels will consist of the following positions:

- Apprentice Coach
- Tasracing Racing Operations Manager
- Tasracing Officials
- Chairman of Stewards
- Tasracing Integrity Unit delegate
- Tasmanian Jockey Association representative

The Apprentice Jockey Panel will be responsible for considering new applications for apprentice jockeys as well as any other employment matter which would relate to an apprentice indenture. Extensions or loan agreements will also be considered by the Panel.

The Riding Review Panel will consider any skills related matters involving apprentice jockeys or senior jockeys.

Licensing Guidelines

The following guidelines should be viewed generally with each applicant being assessed on their individual merits with the Tasracing Integrity Unit reserving the right to have any person appear for interview.

New Applicant:	
Trainers:	First time applicants or persons applying for an upgrade are to be interviewed by the Licensing Panel
Jockeys:	First time applicants to be interviewed by the Licensing Panel if recommended by Stewards
Apprentices:	Initial applications will be determined by the Apprentice Jockey Panel consisting of representatives of Tasracing and the Tasracing Integrity Unit. Indentured Apprentices are required to submit a renewal application and a medical to the TIU each licensing season.
Trials Rider:	To be approved by the TIU via a Chairman's Book.
Stable Foreperson:	Persons applying for an initial upgrade to be interviewed by the Licensing Panel.
Riders Agent:	Initial applications to be interviewed by the Licensing Panel.
Stable Employees (Non-Riding) & (Trackwork Riding):	To be approved by the TIU via a Chairman's Book, including Transfers of Employment or Cancellation of Registration.
Racing Manager:	To be approved by the TIU via a Chairman's Book.
Farrier:	To be approved by the TIU via a Chairman's Book.
Restricted Plating:	To be approved by the TIU via a Chairman's Book.
Renewals:	All categories to be approved by the TIU via a Chairman's Book.
Interstate Applicants:	Each interstate applicant will be assessed on their merits given the licence held and experience obtained through the appropriate jurisdiction where the individual has been licensed.

Licence applications may be referred to the Racing Integrity Committee for feedback if deemed necessary after the Licensing Panel interview has been conducted.

Licensing Review Guidelines

All licensed participants are subject to review at any time but, at least on an annual basis. Relevant matters for the Tasracing Integrity Unit to consider include:

- (a) If the participant has been found guilty of breaches of the Rules of Racing on multiple occasions;
- (b) If a horse that the participant is responsible for is not presented in a way public confidence can be guaranteed;
- (c) If the participant engages in actions that are detrimental to the image of the industry and public perception;
- (d) If the participant fails to meet a level of activity commensurate with the licence category; or
- (e) If the participant no longer meets the requirements of a "fit" and "proper" person.

The Tasracing Integrity Unit may issue a show cause notice on any participant, who is deemed not to meet the guidelines, as to why they should retain their licence.

Renewals

All licence renewals are issued at the discretion of the Tasracing Integrity Unit to a person who has lodged a completed renewal application form accompanied with the prescribed fee and any other required documentation. Renewal applications are reviewed by the Operations team and the Chairman of Stewards before being presented to the Chief Racing Integrity Officer.

The above Licensing Procedures refer to all licences, whether they are a new applicant, an upgrade, or a renewal.

Licence Categories

Stable Employees

Stablehand (Provisional)

Fee: See schedule of fees

The holder of a *Stablehand (Provisional) Licence* may, under the supervision or instructions of the employing trainer, assist with the training, management, care and control of horses at the trainer's registered property for a maximum period of 30 days.

NB: *This licence is for persons that have not previously held a Thoroughbred or Harness licence in any state in Australia. The licence is issued to allow the applicant and the trainer time to assess employment suitability.*

During the provisional period the applicant is not permitted to assist any other trainer or undertake riding activities during this trial period.

A *Stablehand (Provisional) Licence* is issued at the discretion of the Tasracing Integrity Unit to a person who has:

- Attained the age of fourteen (14) years. (Parental consent required for applicants under the age of 18 years.)
- Lodged a completed Provisional Licence application form, co-signed by the employing trainer.
- Provided evidence of identity. (*Refer to Page 4*)

To continue working at the end of the provisional period persons must submit a full application prior to the expiry date of the provisional licence and provide all required documentation relevant to a full Stablehand licence.

Stable Employee (Non-Riding)

Fee: See Fee Schedule

The holder of a *Stable Employee (Non-Riding) Licence* may, under the supervision or instructions of a licensed trainer, assist with the training, management, care and control of horses and assist with pre-race preparation of, and post-race procedures affecting a horse. Stable Employees are **not permitted** to mount any registered racehorse either on the trainer's property or any registered racecourse unless also registered for trackwork riding duties.

A *Stable Employee Licence* is issued at the discretion of the Tasracing Integrity Unit to a person who has:

- Attained the age of fourteen (14) years. (Parental consent required for applicants under the age of 18 years.)
- Lodged a completed application form with the prescribed fee.
- For persons over the age of eighteen (18) years, submitted a current National Police Record Check (*Refer to details on Page 4*).
- For persons working with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Page 4*)
- Provided evidence of identity. (New applicants only if not previously provided to the TIU) (*Refer to Page 4*)
- For new applicants (as defined), acknowledged they will complete the mandatory training and submit evidence of completion within three (3) months of being licensed.
- For a licence renewal, submitted evidence of completion for mandatory training if not previously provided.
- For applicants who hold an equivalent interstate licence at the time of applying, LR 19.1(c) is applicable and reads – “A *Stable Employee currently licensed in another jurisdiction may continue to undertake duties on that licence for a Tasmanian licensed trainer under the following provisions.*
 - i) *A license application is lodged with the Tasracing Integrity Unit prior to commencing work and a satisfactory clearance is obtained by the Tasracing Integrity Unit from the PRA where the person is currently licensed.*
 - ii) *All outstanding documentation including criminal history record check is provided to the Tasracing Integrity Unit within 30 days of the initial application.*
 - iii) *The person may only perform roles for one nominated trainer until a Tasmanian licence application is approved.*

The holder of a *Stable Employee (Trackwork Rider) Licence* may under the supervision or instructions of a licensed trainer, assist with the training, management, care, and control of horses and assist with pre-race preparation of, and post-race procedures affecting a horse. The holder of this licence may also perform trackwork duties for any licensed trainer after being assessed as competent to do so by the TIU.

Please do not apply for a trackwork riding stable employee licence unless you are ready to have a riding assessment at the time of the application. this privilege can always be added to a licence later.

A *Stable Employee (Trackwork Rider) Licence* is issued at the discretion of the Tasracing Integrity Unit to a person who has:

- Attained the age of fourteen (14) years. (Parental consent required for applicants under the age of 18 years.)
- Lodged a completed application form with the prescribed fee.
- For persons over the age of eighteen (18) years, submitted a current National Police Record Check. (*Refer to Page 4*)
- For persons working with participants under the age of eighteen (18) years of age, submitted a copy of their Working with Vulnerable People card (*Refer to Page 4*)
- Provided evidence of identity. (New applicants only if not previously provided to the TIU) (*Refer to Page 4*)
- For new applicants (as defined), acknowledged they will complete the mandatory training and submit evidence of completion within six (6) months of being licensed.
- For a licence renewal, submitted evidence of completion for the mandatory training if not previously provided.
- Submitted a full medical examination report showing appropriate fitness to ride and any other medical information as required and every following five (5) years thereafter for persons up to 64 years of age. Persons aged 65 years and older must submit a medical examination report annually. The Tasracing Integrity Unit reserves the right to request a medical report from an applicant at any time if considered necessary.
- Submitted Third Party Evidence form with respect to riding experience completed by employing trainer.
- Undertaken a riding ability assessment to satisfaction of Stewards. Assessments are conducted by a full time TIU Steward or another appropriately authorised delegate.
- For applicants who hold an equivalent interstate licence at the time of applying. LR 19.1(e) is applicable and reads – “A Trackwork rider, who is currently licensed in another jurisdiction may continue to undertake duties on their interstate licence for a Tasmanian licensed trainer under the following provisions.
 - i) A license application is lodged with the Tasracing Integrity Unit prior to commencing any trackwork duties; a satisfactory clearance is obtained by the Tasracing Integrity Unit from the PRA where the person is currently licensed and, if required, has undertaken a riding ability assessment to the satisfaction of Stewards or appointed track steward, prior to undertaking any riding duties.
 - ii) All outstanding documentation including criminal history record check and medical examination report is provided to the Tasracing Integrity Unit within 30 days of the initial application.
 - iii) The person may only perform roles for one nominated trainer until a Tasmanian licence application is approved.

The holder of a *Visiting Interstate Stable Employee Licence* may under the supervision or instruction of the Visiting licensed trainer they are registered to assist with the training, management, care and control of horses and assist with pre-race preparation of, and post-race procedures affecting a horse. The holder of this licence may also perform trackwork duties for the visiting licensed trainer only if permitted to do so in their home state.

A *Visiting Interstate Stable Employee Licence* is issued at the discretion of the Tasracing Integrity Unit to a person who has:

- A current Stable Employee licence issued by their home PRA.
- Lodged a completed application form.
- Been named by a Visiting Trainer on their application for a Permit to Train in Tasmania.

NB: This licence will only be active for the period the Visiting Trainer remains in Tasmania and to assist with horses trained by the Visiting Trainer.

Stable Foreperson

Fee: \$90.00

The holder of a *Stable Foreperson Licence* may, under the supervision or instructions of a licensed trainer, assist with the training, management, care, and control of horses and assist with pre-race preparation of, and post-race procedures affecting a horse. Furthermore, a Stable Foreperson may fulfil the duties for and on behalf of a trainer during that trainer's absence. A Stable Foreperson is not permitted to mount any registered racehorse either on the trainer's property or any registered racecourse unless also registered for trackwork riding duties.

A *Stable Foreperson* must have held:

- A stable employee's licence for a minimum of one (1) year with an Open Permit or Trainer A in the period immediately preceding the date when an application is received by the TIU;
- A Jockey licence, or
- A trainer's licence.

A *Stable Foreperson Licence* is issued at the discretion of the Tasracing Integrity Unit to a person who has:

- Attained the age of eighteen (18) years.
- Lodged a completed application form with the prescribed fee.
- Provided evidence of identity. (New applicants only) (*Refer to Page 4*)
- Submitted a current National Police Record Check. (*Refer to details on Page 4*)
- For persons working with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Page 4*)
- Submitted a written reference from previous employing trainer.
- Submitted a written statement from the employing trainer outlining the reasons for employing/requiring a Stable Foreperson and/or the trainer attend an interview with the Licensing Panel.
- Completed the mandatory training and submitted evidence of completion if not previously provided.
- Had a successful interview with the Licensing Panel (Only required for new applicants, upgrades or other persons determined by the Tasracing Integrity Unit).

If intending to perform any trackwork duties:

- Ticked the appropriate box on the application and lodged a medical examination form completed by a Medical Practitioner noting fitness to ride and any other medical information as required and then every 5 years following to the age of 64 years. Persons aged 65 years and older must submit a medical examination report annually. (No additional fee is applicable). The Tasracing Integrity Unit reserves the right to request a medical report from an applicant at any time if considered necessary.
- Submitted Third Party Evidence form with respect to riding experience completed by employing trainer.
- Undertaken a trackwork riding ability assessment to the satisfaction of Stewards. Wherever practical, this assessment should be conducted by a full time TIU Steward.

NB: The employing Trainer must satisfy the need to employ a Stable Foreperson. (While each application will be considered on its merits, generally the employing trainer should have at least 8 horses in work)

Racing Manager

Fee: See Fee Schedule

The holder of a *Racing Manager Registration* is an employee of a Trainer who oversees the daily operations in a Thoroughbred racing office with duties such as liaising with existing and/or prospective owners. NB: This type of registration does not give permission to undertake race day or stable activities.

A *Racing Manager Registration* is issued at the discretion of the Tasracing Integrity Unit, who may impose any conditions on a registration at any time, to a person who has:

- Attained the age of eighteen (18) years.
- Employment with the holder of a Trainer A licence issued by the TIU.
- Lodged a completed application form with the prescribed fee.
- Submitted a current National Police Record Check (*Refer to details on Page 4*).
- For persons working with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Page 4*)
- Provided evidence of identity. (New applicants only if not previously provided to the TIU) (*Refer to Page 4*)

The initial application to have a person indentured as an *Apprentice Jockey* must be submitted to Tasracing for consideration by the Apprentice Jockey Panel which includes representatives from Tasracing and the TIU.

Once approved by the Apprentice Jockey Panel, applicants must ensure that the following has been provided to or undertaken with the TIU: –

- Full medical examination report showing appropriate fitness to ride and any other medical information as required, if not previously submitted to the TIU for the current racing season. The Tasracing Integrity Unit reserves the right to request a medical report from an applicant at any time if considered necessary.
- Previous riding history of applicant, if applicable.
- For persons over the age of eighteen (18) years, submitted a current National Police Record Check if required. (*Refer to details on Page 4*)
- For persons working with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Page 4*)
- Clearance from Principal Racing Authority where last licensed, if applicable.
- Next of Kin and Emergency Medical Information on the prescribed form.
- Provided GST and EFT details
- Been assessed by an independent medical practitioner as determined by Tasracing if the person has previously sustained a career ending injury or a major injury.
- Completed a satisfactory annual Baseline Concussion Test.
- To be indentured must have ridden trackwork for the applying trainer for a minimum of six (6) months unless special circumstances can be demonstrated to the satisfaction of the Tasracing Integrity Unit and submitted evidence of any training requirements as mandated by Tasracing.
- To commence riding in official trials must have completed at least ten (10) satisfactory jump-outs over a three-month period, or a lesser number if deemed appropriate following assessment by the Chairman of Stewards in consultation with the Apprentice Coach and submitted recorded details from Apprentice Riding Record Book. Must submit evidence of any training requirements as mandated by Tasracing.
- To obtain a permit to ride in races, must have completed at least twenty (20) satisfactory trial rides during a period of not less than three (3) months but not exceeding five (5) months to a level deemed satisfactory by the Stewards in consultation with the Apprentice Coach
- If the applicant is not an Australian Citizen, information listed on Page 5 for International applicants must also be submitted.

Indentured apprentices must submit the following to the Tasracing Integrity Unit at the commencement of each racing season:

- Renewal application including Next of Kin and Emergency Medical Information.
- Full medical examination report showing appropriate fitness to ride and any other medical information as required.
- Completed a satisfactory annual Baseline Concussion Test.
- A Betting Information Declaration form.
- For a licence renewal, must have ridden in a minimum of 20 races within the previous 12-month period and must compete on a regular basis with no more than six (6) weeks between race rides without reasonable explanation to the satisfaction of the Tasracing Integrity Unit.

Visiting Apprentice Jockey must provide the following to the Tasracing Integrity Unit prior to riding at any race or trial meeting in Tasmania:

- Visiting apprentice application.
- Next of Kin and Emergency Medical Information on the prescribed form.
- Permission letter from Master to ride in Tasmania including advice as to who will be in charge of the apprentice if the registered Master is not in attendance at the meeting.
- **NB:** A Visiting Apprentice Jockey will only be granted permission to undertake riding duties in Tasmania for a 48-hour period unless application is made for permission to extend that time to participate in trackwork or trials.
- **For International applicants – A Baseline Concussion Test may be required if deemed appropriate by the Tasracing Integrity Unit at time of arrival.**

The holder of a *Jockey A Licence* may ride at any race meeting, trial, jump out or trackwork held within the State of Tasmania.

A *Jockey A Licence* is issued at the discretion of the Tasracing Integrity Unit to a person who has:

- Completed an approved Apprenticeship.
- Lodged Statement of Attainment for Certificate IV in Racing (Jockey) or other equivalent evidence as approved by Tasracing.
- Lodged a completed application form, including Next of Kin and Emergency Medical Information with the prescribed fee.
- Provided evidence of identity. (New applicants only) (*Refer to Page 4*)
- Submitted a current National Police Record Check if required. (*Refer to details on Page 4*)
- For persons working with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Page 4*)
- Submitted a full medical examination report showing appropriate fitness to ride and any other medical information as required. The Tasracing Integrity Unit reserves the right to request a medical report from an applicant at any time if considered necessary.
- Been assessed by an independent medical practitioner as determined by Tasracing if the person has previously sustained a career ending injury or a major injury. (not applicable for licence renewal)
- Completed a satisfactory annual Baseline Concussion Test.
- Submitted a Betting Information Declaration form.
- Provided GST and EFT Details.
- Had a successful interview with the Licensing Panel. (Only required for new applicants, upgrades or other persons determined by the Panel). The Licensing Panel must fully consider any submission received from Tasracing and/or the Riding Review Panel in relation to a Jockey A application.
- **If currently licensed as a Jockey by another Australian jurisdiction**-only personal details, Betting Declaration, Next of Kin and Emergency Medical Information is required to be submitted on the prescribed form in accordance with the National Jockey Licence Policy.
- **If currently licensed as a Jockey by an International Jurisdiction**-Personal details, Betting Declaration, Next of Kin and Emergency Medical Information is required to be submitted. A Baseline Concussion Test may be required if deemed appropriate by the Tasracing Integrity Unit at the time of arrival.
- Fulfil any international applicant requirements if applicable. (*See Page 5*)
- For a licence renewal, must have ridden in a minimum of 20 races within the previous 12 months period. If a rider has had extensive time away from riding, they may be required to complete trial rides before returning to race riding as recommended by Stewards. Trackwork and completed trial rides may be taken into consideration when assessing activity levels. Applicants may be required to attend licensing panel if their activity is determined to be at a low level.

Victorian Licensed Jumps Jockey A: Persons holding this category of licence with Racing Victoria Limited may apply for a licence in Tasmania and be permitted to ride in trials, jump outs and trackwork and in any races at the discretion of the Tasracing Integrity Unit.

Victorian Licensed Jumps Jockey B: Persons holding this category of licence with Racing Victoria Limited may apply for a licence in Tasmania and be permitted to ride in trials, jump outs or trackwork held within the state of Tasmania.

Trainer & Jockey – Dual Licence: Persons eligible to be licensed as a Jockey and a Trainer may apply for a dual licence subject to the requirements of Tasmanian Local Rule 15.21.

The holder of a *Riders' Agent Licence* is permitted to register agreements with no more than three Jockeys inclusive of apprentice jockeys where the agreement must be with the Master, who ride regularly in Tasmania. A Riders' Agent shall represent only persons in respect of whom they have obtained specific approval of the Principal Racing Authority in Tasmania.

NB: A Riders' Agent shall **NOT** be a member or employee of Tasracing Pty Ltd or the Tasmanian Racing Appeal Board.

A *Riders' Agent Licence* is issued at the discretion of the Tasracing Integrity Unit to a person who has:

- Attained the age of eighteen (18) years.
- Lodged a completed application form with the prescribed fee.
- Provided evidence of identity. (New applicants only) (*Refer to Page 4*)
- Submitted a Riders' Agent/Jockeys agreement completed by the rider/s or apprentice master/s in respect of whom they seek to be licensed.
NB: Applicants must make similar applications for the variation of their licence to include additional clients.
- Submitted a current National Police Record Check. (*Refer to details on Page 4*)
- For persons working with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Page 4*)
- Had a successful interview with the Licensing Panel. (Only required for new applicants or other persons as determined by the Tasracing Integrity Unit).

The holder of an *Approved Trials Rider Licence* may ride trackwork, jumpouts and official trials within the State of Tasmania.

NB: If intending to undertake stablehand duties at a trainer's registered establishment and/or at trial or race meetings, must also hold a Stable Employee licence (no additional fee will be applicable)

An *Approved Trial Rider* must have previously been licensed as –

- a jockey; or
- an apprentice approved to ride in races; or
- a cross country rider; or
- a picnic or amateur rider who has been approved to ride in races.

An *Approved Trial Rider Licence* is issued at the discretion of the Tasracing Integrity Unit to a person who has:

- Lodged a completed application form, including Next of Kin and Emergency Medical details, with the prescribed fee.
- Provided evidence of identity. (New applicants only) (*Refer to Page 4*)
- For persons over the age of eighteen (18) years, submitted a current National Police Record Check if required. (*Refer to details on Page 4*)
- For persons working with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Page 4*)
- Submitted a full medical examination report showing appropriate fitness to ride and any other medical information as required. The Tasracing Integrity Unit reserves the right to request a medical report from an applicant at any time if considered necessary.
- Been assessed by an independent medical practitioner as determined by Tasracing if the person has previously sustained a career ending injury or a major injury. (not applicable for licence renewal)
- Completed a satisfactory annual Baseline Concussion Test.
- Provided GST and EFT Details.
- Been assessed and interviewed (if necessary) with respect to current riding skill ability and regularity by Stewards who will provide a recommendation to the Tasracing Integrity Unit for consideration of the application.
- If necessary, had a successful interview with the Licensing Panel. (May only be required if a negative report is received from Stewards).
- Completed at least 10 satisfactory jumpouts, if determined necessary by Stewards.
- Completed the mandatory training and submitted evidence of completion if not previously provided.
- If applicable, fulfil international applicant requirements. (See General Requirements)
- For a licence renewal, must have ridden in a minimum of 20 trials within the previous 12-month period. Trackwork and completed trial rides may be taken into consideration when assessing activity levels. Applicants may be required to attend licensing panel if their activity is determined to be at a low level.

Trainers

Pre-Trainer

Fee: \$757.00

The holder of a *Pre-Trainer Licence* may break in, prepare and educate a registered thoroughbred horse prior to the horse being sent to a trainer for official training and/or racing. A Pre-Trainer may not trial or nominate any horse for racing.

Persons must meet one of the following pre-requisites to have an application for this category of licence considered.

In the period immediately preceding the submission of an application to the TIU have been -

- A registered thoroughbred Stablehand for a minimum of one (1) year; or
- A registered thoroughbred Stable Foreperson for a minimum of one (1) year; or
- A licensed Harness Trainer for a minimum of one (1) year; or
- Have experience in equine pursuits (in a non-licensed capacity) for a minimum of five (5) years; or
- A licensed Jockey A; or
- An interstate or overseas licensed thoroughbred Trainer; or
- A licensed thoroughbred Tasmanian Trainer.

Licences are issued at the discretion of the Tasracing Integrity Unit to a person who meets the above pre-requisites and who:-

- Has attained the age of eighteen (18) years.
- Has lodged a completed application form with the prescribed fee.
- Has provided evidence of identity. (If not previously provided to the TIU) (*Refer to Page 4*)
- Has made payment of ATA Public Liability Insurance Policy premium or provide Certificate of Currency of other equivalent policy.
- Ensures that in carrying out activities under this licence they comply with any requirements imposed upon them under the *Workers Rehabilitation and Compensation Act 1988 (WRCA)* from time to time and furnish to Tasracing a certificate of currency of insurance for the purposes of the WRCA within seven (7) days of being requested to do so by Tasracing.
- Ensures that in carrying out activities under this licence they only carry out those activities on land on which they may lawfully do so under the *Land Use Planning and Approvals Act 1993* and in doing so comply with the requirements of any authority having statutory or regulatory jurisdiction over that land.
- Submitted one (1) written reference from a currently licensed trainer.
- Submitted a current National Police Record Check if required. (*Refer details on Page 4*)
- For persons working with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Page 4*)
- For new applicants, provided evidence of a current Level 1 First Aid certificate attained by the applicant.
- Had a successful interview with the Licensing Panel. (Only required for new applicants, upgrades or other persons determined by the Tasracing Integrity Unit).
- Undergone a stable inspection to the satisfaction of the TIU. **NB:** This will be conducted following a successful interview with the Licensing Panel.
- Completed the mandatory training and submitted evidence of completion if not previously provided.

If intending to perform any trackwork duties:

- Ticked the appropriate box on the application and lodged a medical examination form completed by a Medical Practitioner noting fitness to ride and any other medical information as required and then every 5 years following to the age of 64 years. Persons aged 65 years and older must submit a medical examination report annually. (No additional fee is applicable). The Tasracing Integrity Unit reserves the right to request a medical report from an applicant at any time if considered necessary.
- Undertaken a trackwork riding ability assessment to the satisfaction of the TIU. (New applicants only).

The holder of an *Owner/Trainer* licence may only train registered thoroughbred horses which that person owns or partly owns, or which is owned by the person's spouse, other domestic partner, parent, sibling or child, or any horse approved by the Tasracing Integrity Unit upon the written application of the person. Owner/Trainers are not permitted to train for syndicates.

Persons must meet one of the following pre-requisites to have an application for this category of licence considered. In the period immediately preceding the submission of an application to the TIU have held -

- A thoroughbred stable employee's licence, a Stable Foreperson licence or a Pre-Trainer's licence for at least one year; or
 - A Jockey licence; or
 - A Harness Trainer's licence for a minimum of one (1) year.
- OR, if the applicant does not currently hold a licence as stated above –
- Previously have held (with a PRA), an Owner-Trainer thoroughbred licence (or its equivalent or higher level) for a minimum of two (2) years and have been licensed within three (3) years from the date that a (full) application is submitted to the Tasracing Integrity Unit.

Confirmed licensing of an equivalent level with an interstate racing jurisdiction will also be used to evaluate an application.

Licences are issued at the discretion of the Tasracing Integrity Unit to a person who meets the above pre-requisites and who:

- Has attained the age of eighteen (18) years.
 - Has lodged a completed application form with the prescribed fee.
 - Has provided evidence of identity. (If not previously provided to the TIU). (*Refer to Page 4*)
 - Has submitted one (1) written reference from a currently licensed trainer.
 - Has provided evidence of previously held non-thoroughbred licence (if applicable).
 - Has been granted a clearance from the Principal Club or controlling body where previously licensed, if applicable.
 - Has submitted a current National Police Record Check if required. (*Refer to details on Page 4*)
 - For persons that employ or work with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Page 4*)
 - Has made payment of ATA Public Liability Insurance Policy premium or provide Certificate of Currency of other equivalent policy.
 - Ensures that in carrying out activities under this licence they comply with any requirements imposed upon them under the *Workers Rehabilitation and Compensation Act 1988 (WRCA)* from time to time and furnish to Tasracing a certificate of currency of insurance for the purposes of the WRCA within seven (7) days of being requested to do so by Tasracing
 - Ensures that in carrying out activities under this licence they only carry out those activities on land on which they may lawfully do so under the *Land Use Planning and Approvals Act 1993* and in doing so comply with the requirements of any authority having statutory or regulatory jurisdiction over that land.
 - For new applicants, provided evidence of a current Level 1 First Aid certificate attained by the applicant.
 - Satisfactorily completed the Trainer's questionnaire (if not previously licensed as a trainer).
 - Provided GST and EFT Details.
 - For new applicants (as defined), acknowledged they will complete the mandatory training required for Trainers and submit evidence of completion within twelve (12) months of being licensed.
 - For a licence renewal, submitted evidence of mandatory training as approved by Tasracing, if not previously provided.
 - Had a successful interview with the Licensing Panel. (Only required for new applicants, upgrades or other persons determined by the Tasracing Integrity Unit).
 - Undergone a stable inspection to the satisfaction of the TIU. NB: This will be conducted following a successful interview with the Licensing Panel.
- If intending to perform any trackwork duties:**
- Ticked the appropriate box on the application and lodged a medical examination form completed by a Medical Practitioner noting fitness to ride and any other medical information as required and then every 5 years following to the age of 64 years. Persons aged 65 years and older must submit a medical

examination report annually. (No additional fee is applicable). The Tasracing Integrity Unit reserves the right to request a medical report from an applicant at any time if considered necessary.

- Undertaken a trackwork riding ability assessment to the satisfaction of the TIU. (New applicants only).

Open Permit Trainer

Fee: \$1191.00

The holder of an *Open Permit* licence may train any registered thoroughbred horse.

Open Permit applicants will be assessed in relation to their competency to train for the public. Persons must meet one of the following pre-requisites to have an application for this category of licence considered. In the period immediately preceding the submission of an application to the TIU have held -

- A thoroughbred stable employees licence for at least three consecutive years; or
 - A thoroughbred Stable Foreperson licence for at least two consecutive years; or
 - An Owner/Trainer thoroughbred licence for at least one year; or
 - A Jockey licence; or
 - A Harness Trainer's licence for a minimum of five (5) years.
- OR, if the applicant does not currently hold a licence as stated above –
- Previously have held (with a PRA), an Open Permit thoroughbred trainer licence (or its equivalent or higher level) for a minimum of three (3) years and have been licensed as such within three (3) years from the date that a (full) application is submitted to the Tasracing Integrity Unit.

Confirmed licensing of an equivalent level with an interstate racing jurisdiction can be used to evaluate an application.

Licences are issued at the discretion of the Tasracing Integrity Unit to a person who meets the above pre-requisites and who:

- Has attained the age of eighteen (18) years.
- Has lodged a completed application form with the prescribed fee.
- Has provided evidence of identity. (If not previously provided to the TIU) (*Refer to Page 4*)
- Has submitted one (1) written reference from a person currently licensed at Trainer A or Open Permit level.
- Has provided three (3) credit references from racing suppliers. For new applicants (as defined); provided financial statements for the preceding six (6) months.
- For renewals; provided financial statements for the preceding six (6) months if requested by the TIU.
- Has been granted a clearance from the Principal Club or controlling body where previously licensed, if applicable.
- Has provided evidence of previously held non-thoroughbred licence (if applicable).
- Has submitted a current National Police Record Check if required. (*Refer to details on Page 4*)
- For persons that employ or work with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Page 4*)
- Has provided a list of prospective horses and owners.
- Has made payment of ATA Public Liability Insurance Policy premium or provided a Certificate of Currency of other equivalent policy.
- Ensures that in carrying out activities under this licence they comply with any requirements imposed upon them under the Workers Rehabilitation and Compensation Act 1988 (**WRCA**) from time to time and furnish to Tasracing a certificate of currency of insurance for the purposes of the WRCA within seven (7) days of being requested to do so by Tasracing.
- Ensures that in carrying out activities under this licence they only carry out those activities on land on which they may lawfully do so under the *Land Use Planning and Approvals Act 1993* and in doing so comply with the requirements of any authority having statutory or regulatory jurisdiction over that land.
- For new applicants, provided evidence of a current Level 1 First Aid certificate attained by the applicant.
- Satisfactorily completed the Trainer's questionnaire. (If not previously licensed as a trainer).
- Provided GST and EFT Details.
- For new applicants (as defined), acknowledged that they will complete the mandatory training required for a trainer and submit evidence of completion within twelve (12) months of being licensed.
- For a licence renewal, submitted evidence of completion of the mandatory training as approved by Tasracing, if not previously provided.

- Had a successful interview with the Licensing Panel. (Only required for new applicants, upgrades, interstate or overseas applicants or other persons determined by the Tasracing Integrity Unit).
- Undergone a stable inspection to the satisfaction of the TIU. NB: This will be conducted following a successful interview with the Tasracing Integrity Unit.

If intending to perform any trackwork duties:

- Ticked the appropriate box on the application and lodged a medical examination form completed by a Medical Practitioner noting fitness to ride and any other medical information as required and then every 5 years following to the age of 64 years. Persons aged 65 years and older must submit a medical examination report annually. (No additional fee is applicable). The Tasracing Integrity Unit reserves the right to request a medical report from an applicant at any time if considered necessary.
- Undertaken a trackwork riding ability assessment to the satisfaction of the TIU. (New applicants only)

Trainer A

Fee: \$1286.00

The holder of a *Trainer A* licence may train any registered thoroughbred horse. Trainer A applicants must have held

- An Open Permit thoroughbred licence (or the equivalent interstate racing jurisdiction level) for at least two consecutive years in the period of time immediately preceding the application.
- Or, if not currently licensed, previously have held an "A" level thoroughbred trainer licence (or its equivalent) (with a PRA) for a minimum of five (5) years and have been licensed as such within three (3) years from the date that a (full) application is submitted to the Tasracing Integrity Unit.

Confirmed licensing of an equivalent level with an interstate racing jurisdiction can be used to evaluate an application.

Licences are issued at the discretion of the Tasracing Integrity Unit to a person who:

- Has attained the age of eighteen (18) years.
- Has lodged a completed application form with the prescribed fee.
- Has provided evidence of identity. (If not previously provided to the TIU) (*Refer to Page 4*)
- Has submitted one (1) written reference from a person currently licensed at Trainer A level.
- Has provided three (3) credit references from racing suppliers.
- For new applicants (as defined); has provided financial statements for the preceding six (6) months.
- For renewals; provided financial statements for the preceding six (6) months if requested by the TIU.
- Has been granted a clearance from the Principal Club or controlling body where previously licensed, if applicable.
- Has submitted a current National Police Record Check if required. (*Refer details on Page 4*)
- For persons that employ or work with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card (*Refer to Page 4*)
- Has made payment of ATAPublicLiabilityInsurancePolicy premium or provided a Certificate of Currency of other equivalent policy.
- Ensures that in carrying out activities under this licence they comply with any requirements imposed upon them under the *Workers Rehabilitation and Compensation Act 1988 (WRCA)* from time to time and furnish to Tasracing a certificate of currency of insurance for the purposes of the WRCA within seven (7) days of being requested to do so by Tasracing.
- Ensures that in carrying out activities under this licence they only carry out those activities on land on which they may lawfully do so under the *Land Use Planning and Approvals Act 1993* and in doing so comply with the requirements of any authority having statutory or regulatory jurisdiction over that land
- Provided GST and EFT Details.
- Completed the mandatory training required for a trainer and submitted evidence of completion if not previously provided.
- Had a successful interview with the Licensing Panel. (Only required for new applicants, upgrades, interstate or overseas applicants or other persons determined by the Tasracing Integrity Unit).
- Undergone a stable inspection to the satisfaction of the TIU. **NB:** This will be conducted following a successful interview with the Licensing Panel.

If intending to perform any trackwork duties:

- Ticked the appropriate box on the application and lodged a medical examination form completed by a Medical Practitioner noting fitness to ride and any other medical information as required and then

every 5 years following to the age of 64 years. Persons aged 65 years and older must submit a medical examination report annually. (No additional fee is applicable). The Tasracing Integrity Unit reserves the right to request a medical report from an applicant at any time if considered necessary.

- Undertaken a trackwork riding ability assessment to the satisfaction of the TIU. (New applicants only)

Training Partnerships

1. Permission to train in partnership may be issued at the discretion of the Tasracing Integrity Unit to-
 - (a) Two (2) trainers who have been granted a trainer's licence under LR 15 provided that one of the trainers is licensed as Trainer A.
 - (b) Three (3) trainers who are immediate family members and who have each been granted a trainer's licence under LR 15 provided that one of the trainers is licensed as Trainer A.
 - (c) Trainers who have permission to train in partnership:
 - i) Must not train any horses as individuals or in another training partnership;
 - ii) Share all responsibilities, duties and obligations under the Rules in regard to the training of racehorses.
 - (d) An application for permission to train in a partnership shall:
 - i) Be in such form;
 - ii) Provide such information; and
 - iii) Be accompanied by such fee as is prescribed by the Tasracing Integrity Unit.
2. The Tasracing Integrity Unit may:
 - (a) Without being required to give any reasons refuse permission to train in partnership; or
 - (b) Grant permission subject to such terms and conditions as the Tasracing Integrity Unit thinks fit, including but not limited to restrictions regarding duration and locality or both.
3. The Tasracing Integrity Unit may at their discretion, at any time:
 - (a) Revoke permission to train in partnership, including without limitation where any of the applicants cease to meet the requirements to be granted permission in accordance with the Policy, or where any of the training partners have been suspended or disqualified; or
 - (b) Vary or amend any of the terms or conditions of any permission to train in partnership.
4. It is a precondition of the grant of permission to train in partnership that:
 - (a) Applicants do not hold a licence or permit to train in another racing jurisdiction, other than a licence or permit to train in partnership with each other;
 - (b) The Stewards are satisfied as to the bona fides of the training partnership;
 - (c) A minimum of 8 horses shall be trained in the partnership.
5. The Tasracing Integrity Unit may at their absolute discretion relieve applicants for permission to train in partnership from the preconditions set out in this policy.
6. Where there has been a breach of the Rules by any of the trainers training in partnership, then all trainers shall be deemed jointly and severally responsible and may be charged and penalised accordingly.
7. Where a penalty has been imposed by another Principal Racing Authority upon any of the trainers in a training partnership, then all trainers shall be deemed jointly and severally responsible for the purposes of adoption or recognition of that penalty in accordance with these Rules.
8. Clauses 6 and 7 do not apply where the relevant breach or penalty imposed:
 - (a) Does not relate in any way to the training of racehorses; or
 - (b) Involves conduct of a kind that may be subject to a penalty under AR229. Applications must be made on the approved Tasracing Integrity Unit form. Applicants may be required to attend an interview with the Licensing Panel.

Definition of Immediate Family

- (a) A spouse, de facto partner, child, parent, grandparent, grandchild or sibling; or
- (b) A child, parent, grandparent, grandchild or sibling of a spouse or de facto partner.

Farriers

Farrier/Restricted Plating

Fee: \$66.00

The holder of a Farrier licence may shoe and plate horses for themselves or other owners or trainers. The holder of a Restricted Plating licence may shoe horses owned and/or trained only by them.

A Farrier or Restricted Plating licence is issued at the discretion of the Tasracing Integrity Unit to a person who has:

- Lodged a completed application form with the prescribed fee.
- Provided evidence of identity. (New applicants only) *(Refer to Page 4)*
- Submitted a current National Police Record Check if required. *(Refer to details on Page 4)*
- For persons that employ or work with participants under the age of eighteen (18) years of age, submitted a copy of their Working With Vulnerable People card *(Refer to Page 4)*
- **Farrier:**
 - Provided copy of Trade Certificate; or
 - Completed Articles of Apprenticeship; or
 - If unable to provide above certificates, have competency assessed to the satisfaction of a person approved by the Tasracing Integrity Unit. References attesting to ability from persons who have utilised the applicant's services would also be advantageous.
- **Restricted Plating:** Provided a Letter of Competency from a qualified and licensed Farrier with at least five (5) years' experience.
