Licence Information

The following information applies to the 2024/2025 thoroughbred racing season and forms part of your application.

APPLICATION FOR RENEWAL FORM

The Application for Renewal of Licence form must be completed and lodged with the Tasracing Integrity Unit (TIU) by **Friday 4 July 2025** to ensure that processing will be completed prior to the commencement of the season on 1 August 2025. Late lodgement will cause delays in processing.

As the preference for renewing applications is now by the SNS online method, all paper-based applications will incur **an administration fee of \$25 in addition** to the prescribed licence fee.

You should obtain and provide a unique email address as soon as possible because it is the TIU's intention to phase out paper-based renewal applications.

Your licence includes the following:

- Photo Identification card
- SMS Messaging* (optional for Approved Trials Rider)
- ATA Public Liability Insurance Policy for Trainers (if required)

(*excluding Stable Employee or Foreman/Trackwork Rider/Farrier and/or Restricted Plating/Riders Agent licencees)

Applications must be lodged either by email, mail, fax or in person to our Prospect office.

Applications cannot be accepted by Stewards or other staff members at race or trial meetings.

SMS MESSAGING SERVICE

An SMS Messaging Service provided through Racing Australia will operate again this season. Text messages will be sent to your mobile phone with important information, which will allow you to be up to date with racing matters affecting trainers, jockeys and the general industry. If you do not have a mobile phone and therefore are unable to utilise this service please deduct \$15.00 from the scheduled fee and make a note on your application to that effect.

LICENCE UPGRADE / CHANGE OF CATEGORY

Should you wish to upgrade your licence or apply for a different category, please contact the TIU to obtain an application form and information with respect to other documentation, which may be required.

PAYMENT

Payment options are included with this application.

APPLICATION FORMS

If you have multiple licenses, you should complete and return each application form to renew that licence. It is however only necessary to pay the **highest fee applicable** except for a Farrier or Restricted Plating licence which attracts a fee in addition to any other licence fee applicable.

THOROUGHBRED RACING CALENDAR

Your details (name & telephone number) will be included in the Thoroughbred Racing Calendar, therefore up-to-date, accurate details are vital for the information contained in this publication. If you do not return the application for licence renewal form by the due date you may not be included in the first issue of the Calendar in the new season. If you do not wish to have your details published, please ensure you answer the question on your renewal application appropriately.

A subscription fee is no longer applicable for the Racing Calendar. Copies are available to all participants at the offices of Tasracing or race clubs free of charge.

PHOTOGRAPHIC IDENTIFICATION

All licensees will be issued with a Photographic ID Licence card for the forthcoming season that must always be worn in a prominent position when participating as a licensed person at a race or trial meeting. You must be able to produce this card upon request of Stewards or other authorized persons.

TRAINERS LICENCE CONDITIONS

☐ Acknowledge I have read, understood and agree to abide by the requirements stipulated in the Code of Practice for Racehorse Welfare (Thoroughbred) published by Tasracing Pty Ltd.

In the event of my licence being granted, I agree:

- (a) That it may be revoked at any time by the Tasracing Integrity Unit in accordance with the Rules of Racing.
- (b) That I shall be bound at all times by the said Rules and By-Laws.
- (c) That I shall be bound by the regulations for the time being in force in respect of any training tracks used by me.
- (d) That no guarantee is given as to the safety or suitability of tracks provided by any Racing Club for training purposes.
- (e) That I will comply with any directions which may be given by the Tasracing Integrity Unit or the Stewards.

- (f) That accommodation of the standard approved by the TIU or the Stewards will be provided by me for apprentices and other employees.
- (g) That I must take out a worker's compensation policy with a licensed insurer to provide indemnity for worker's compensation claims made by the worker in accordance with the *Workers Rehabilitation and Compensation Act 1988*. Workers Compensation legislation largely considers volunteers to be "workers". Trainers may be required to provide evidence of a current worker's compensation insurance policy on the request of the Stewards or TIU official. - (h) That I will furnish satisfactory evidence of the currency of a Public Liability Insurance policy to the equivalent level of the ATA Policy or make payment for inclusion in the ATA Policy.
- (i) That I will open my stables for inspection at any reasonable time to any authorised officer or Steward.
- (j) I am aware that the TIU is collecting this information for the purpose of administering and promoting thoroughbred racing. I understand that the TIU only discloses this information to organisations which help to administer and promote thoroughbred racing and in order to comply with applicable laws and regulations.

COMPULSORY MEDICAL EXAMINATION

All persons 65 years of age or older who want to be registered to perform trackwork duties including trainers must supply a medical examination report for Season 2024/2025.

Any registered doctor can complete the medical examination. **The fully completed form must be returned with your application.** A certificate of fitness will not be accepted.

All persons 14 to 64 years of age who want to be registered to perform trackwork duties including trainers will only be required to supply a medical examination report every 5 years commencing from the 2020/21 season.

- IE: If you last submitted a medical as part of your registration for trackwork during the 2019/20 season you will be required to provide a medical report with your renewal for the 2024/25 season.
- If you have provided a medical report since the 2019/20 season you **will not be required** to provide a medical with this renewal. Additional questions will be asked on your renewal application which **MUST** be answered.

The Tasracing Integrity Unit reserves the right to request a full medical report or further information from a registered medical examiner should it be deemed necessary based on any information supplied.

ALL RIDERS – NOTIFICATION OF INJURY OR ILLNESS

Existing licence or permit holders who, during the period of the licence or permit, suffer a significant injury (e.g. concussion, fracture) or significant illness (e.g. cancer, hepatitis) that could in any way affect their fitness to ride, must inform the TIU at the earliest opportunity. This applies to any significant illness or injury – regardless of whether or not it resulted from a racing incident (e.g. road traffic accident, skiing, hang gliding etc.).

MANDATORY TRAINING REQUIREMENTS

To obtain and/or maintain a licence of any category, participants must comply with any training requirements as mandated by Tasracing from time to time. For information on current training requirements for any licence category, please contact Tasracing via email to www.tasracing.com.au or phone (03) 6212 9333. All licensed persons must attend any workshops mandated by Tasracing as compulsory.

AR.278 – DISQUALIFIED PERSONS BOUND BY RULES DURING DISQUALIFICATION

Subject to subrule (2), if a licensed person is disqualified, that person's licence immediately ceases and becomes void, and that person must make application to a PRA to be relicensed in order to be granted a new licence.

For the duration of a period of disqualification, a disqualified person is and remains bound by, and subject to, the Rules.

AR.23 – SUSPENSION PENDING THE HEARING AND DETERMINATION OF A CHARGE

Without limiting any other rules or Stewards' powers, if a person has been charged with a breach of these Rules (or a local rule of a Principal Racing Authority) or with the commission of an indictable criminal offence, and if the Stewards are of the opinion that the continued participation of that person in racing might pose an unacceptable risk of prejudicing the image, interests, integrity or welfare of racing, the Stewards may pending the hearing and determination of the charge:

- Suspend any licence, registration, right or privilege, granted under these Australian Rules;
- Prevent any horse owned (or part owned) or leased by that person from participating in any race or official trial;
- Order that any registration of the transfer of ownership and/or training of a horse related to that person be prevented or suspended;
- make any other direction or order the Stewards think fit in the interests of racing.

TRACKWORK & APPROVED TRIALS RIDER INFORMATION

Under the Australian Rules of Racing, at all times when mounted on a horse, you wear an approved safety vest, a properly affixed and approved skullcap and approved footwear.

If you intend performing the duties of a strapper at race meetings or working in the stable area for a licensed trainer you must also be licensed as a Stable Employee. (There is no further fee applicable to obtain this licence).

INSURANCE REQUIREMENTS – TRACKWORK RIDERS

- Trainers and/or trackwork riders must negotiate an employment arrangement to ensure an employer/employee relationship is in place.

RIDER VISION STANDARDS

All riders (jockeys, apprentice jockeys, approved trial riders, trackwork riders (including trainers)) should be aware that national standards apply in relation to visual acuity (ability to see clearly).

- Minimum requirements with or without corrective lenses –
 - "good eye" 6/9 or better;
 - "worse eye" 6/18 or better.
- Corrective lenses are acceptable provided that these are "soft contact lenses".
- Monocular vision, visual field defects and diplopia are not acceptable.

LICENSING REVIEW GUIDELINES

All licensed participants are subject to review, on at least an annual basis. Relevant matters for the Tasracing Integrity Unit to consider include:

- (a) If the participant has been found guilty of breaches of the Rules of Racing on multiple occasions;
- (b) If a horse that the participant is responsible for is not presented in a way public confidence can be guaranteed;
- (c) If the participant engages in actions that are detrimental to the image of the industry and public perception;
- (d) If the participant fails to meet a level of activity commensurate with the licence category; or
- (e) If the participant no longer meets the requirements of a "fit" and "proper" person.

The Tasracing Integrity Unit may issue a show cause notice on any participant, who is deemed not to meet the guidelines, as to why they should retain their licence.

The above guidelines refer to all licences, whether they be a new applicant, an upgrade or a renewal.

If you do not provide to Tasracing the personal information requested by this document the main consequences for you is likely to be that Tasracing may not be able to process your application and/or your application may be considered invalid.
