RACE 1 – 6TY YOUNGBLOODS HEAT 4 – 2090 METRES

JACKS N JAZZ NZ sulky was replaced prior to the start.

JACKS N JAZZ NZ broke during the score up and was out of position at the start. This gelding has been placed outside the draw in future mobile start events.

TRUE STEPPER broke during the score up, however, as this mare was in position when the field was released, no action was taken.

ON MY OATH was restrained to the rear of the field shortly after the start.

JACKS N JAZZ NZ broke as the field raced towards the home turn on the final occasion and has been placed on its last chance to race truly.

ISLAS JOY NZ pulled hard throughout, tiring to be beaten in excess of 200 metres. This gelding underwent a post-race veterinary examination that revealed no apparent abnormalities. ISLAS JOY NZ has been stood down until the completion of a satisfactory trial.

Driver Mitch Ford pleaded guilty to a charge under 168(1) in that he carelessly allowed TURQUOISE STRIDE to shift ground over the concluding stages of this event. Mr Ford was fined the sum of \$200.

Stewards inquired into the apparent improved performance of TURQUOISE STRIDE, Trainer Ben Yole stated that he believed that this gelding has benefited from a recent short break and races best when fresh. Stewards noted Mr Yole's comments.

TURQUOISE STRIDE was detained on course for 2.5 hours to allow post-race blood samples to be obtained.

RACE 2 – RHYMES ST CAFÉ EASTLANDS PACE – 2090 METRES

CHOIR QUEEN delayed the start due to a gear adjustment.

BIGLITTLESIS raced roughly after the start.

I OF THE HURRIKANE utilised the sprint lane over the concluding stages.

THEUGLYSISTER utilised the sprint lane over the concluding stages.

Driver Tiarna Ford pleaded guilty to a charge under AHHR 156(2)(a) in that she used the whip with more than wrist only flicking motion. Ms. Ford was fined the sum of \$200.

I OF THE HURRIKANE was detained on course for 2.5 hours to allow post-race blood samples to be obtained.

RACE 3 – 6TY YOUNGBLOODS HEAT 5 – 2090 METRES

BE GOOD BENNY hung out during the score up.

POPNPENNIES was restrained to the rear of the field shortly after the start.

LONGNWINDINGROAD over raced at various stages.

OZZIE MAJOR pulled hard at various stages. This gelding utilised the sprint lane over the concluding stages.

ASHLEYS BLUE CHIP utilised sprint lane.

KARALTA DAZZLER was held up for clear racing room over the concluding stages.

NOBEER NOMORE tired to be beaten in excess of 50 metres. This gelding has been stood down until the completion of a satisfactory trial.

Driver Ryan Backhouse pleaded guilty to a charge under 156(2) in that he used the whip with more than a wrist only flicking motion. Mr Backhouse was fined the sum of \$400.

RACE 4 – TALBOT HOTEL PACE – 2090 METRES

THE GARDENER jibbed in the early stages of the score up.

BETTOR BLAST NZ broke during the score up and was out of position at the start. This filly will continue to be placed outside the draw in future mobile start events.

SVITOLINA LEIS hung out during the early stages of the score up. This filly raced roughly over the concluding stages.

FORSAKEN ME shifted ground over the concluding stages. A warning has been issued on this gelding.

Stewards queried the apparent improved performance of FORSAKEN ME in tonight's event. Trainer Todd Rattray stated the gelding had matured after an extended break, was working well and connections had expected a forward showing in tonight's event. Stewards noted Mr. Rattrays comments.

RACE 5 – 6TY YOUNGBLOODS HEAT 6 – 2090 METRES

BETTERTHANFETTA was out of position at the start despite the efforts of its driver. This horse has been placed on its last chance in the draw.

VIVID STRIDE was held up until utilising the sprint lane.

STAR ROCKER was caught wide in the early stages before working forward to race outside the leader.

JOHN RICHARD pulled hard throughout.

ULTIMATE ME NZ hung in contacting a number of marker pegs approaching the home turn This gelding has been placed on its last chance to race truly.

RADAR STRIDE was held up for clear racing room prior to utilising the sprint lane.

MACH ANGELO was held up for clear racing room upon entering the home straight and at vital stages.

RACE 6 – DIAGRIND PACE – 2090 METRES

Stewards gave Trainer Ben Yole permission under AHHR 158(1) for Driver Gareth Rattray to replace Taylor Ford on SOMEDAN after Ms. Ford advised him of her intention not to drive at tonight's meeting.

MAJOR ASSASSIN caught wide in the early stages and restrained to positioned.

STEVIE JOLT contacted marker pegs. A warning has been placed on this gelding.

HURRICANE ROCK severely checked and subsequently broke by the galloping SON OF RAYSON.

SOMEDAN utilised the sprint lane.

SON OF RAYSON after being severely checked by LOYOLA TRIOS (Kyle Pratten) tired to be beaten in excess of 80 metres. This gelding underwent a post-race veterinary examination that revealed no abnormalities.

LIFEOFBRIAN NZ gave ground to be beaten in excess of 49 metres.

Driver Kyle Pratten pleaded guilty to a charge under AHRR 168(1)(a) in that he carelessly allowed LOYOLA TRIOS to shift ground as the field raced into the back straight on the final occasion when not sufficiently clear of SON OF RAYSON (Cody Crossland) contacting the front legs of that gelding causing it to break and subsequently checking HURRICANE ROCK (Jacob Duggan). Mr Pratten's driver licence has been suspended for a period of 2 race dates from midnight 4 December 2022 until midnight 16 December 2022.

RACE 7 - BASS STRAIT REMOVALS PACE - 1609 METRES

Stewards gave Trainer Ben Yole permission under AHHR 158(1) for Driver Gareth Rattray to replaced Taylor Ford on TO THE LOOKOUT after Ms. Ford advised him of her intention not to drive at tonight's meeting.

WAYONBYE was fractious and failed to circle prior to the start of this event. This gelding has been placed on its last chance in the mobile start draw.

BOLTNMACH gave ground over the concluding stages to be beaten in excess of 46 metres.

SEA HAWKE was inconvenienced by BOLTNMACH as that gelding was giving ground.

Driver Cody Crossland (CAPTAIN COSMONAUT) pleaded guilty to a charge under AHRR 156(2) in that he used the whip with more than a wrist only flicking motion. Mr Crossland was fined the sum of \$400.

RACE 8 – PEPPERS PAINTING AND DECORATING PACE – 2090 METRES

REGAL KENZIE after hanging badly during its preliminary, this mare underwent a pre-race veterinary examination and was a late scratching acting on veterinary advice. REGAL KENZIE has been stood down until the completion of a satisfactory trial.

INDIANNA SANZ pulled hard throughout.

MOLLYS BEST tired to be beaten in excess of 61 metres. This mare underwent a post-race veterinary examination that revealed no apparent abnormalities. MOLLYS BEST has been stood down until the completion of two satisfactory trials. INDIANNA SANZ pulled hard throughout this event.
