# Race 1 - CASCADE DRAUGHT PACE (2090 METRES)

AH MACH NZ hung out shortly after the start before racing outside the leader throughout.

RECKLESS DREAM was checked and broke when AH MACH NZ hung out after the start and was then restrained to the rear of the field.

KERALA STAR NZ was caught wide early before restraining to the rear of the field.

Driver M Ford (JAWBREAKER) was fined the sum of \$400 after pleading guilty to a charge under AHRR156(2)(a). Particulars were that he used his whip with more than a wrist only flicking motion.

### Race 2 - PRYDES EASIFEED PACE (2090 METRES)

ZEUS DAN was inconvenienced in the early stages before working forward to race outside the leader.

MISS BARTY broke free of interference and has been placed on its last chance to race truly.

MAYLEEJAE EAGLE worked forward in the middle stages to race outside the leader before gaining a trail in the middle stages. The gelding utilised the sprint lane to win the event.

LAHOOD tired to be beaten in excess of 52 metres and has been placed on its last chance to race competitively.

I OF THE HURRIKANE tired to be beaten in excess of 84 metres and has been placed on its last chance to race competitively.

MICTON AROHA tired to be beaten in excess of 52 metres and has been placed on its last chance to race competitively.

POPNPENNIES tired to be beaten in excess of 94 metres and has been placed on its last chance to race competitively.

SHAUN TO THE MAX tired to be beaten in excess of 56 metres and has been placed on its last chance to race competitively.

GALAXY DANCER worked forward to race outside the leader before gaining a trail in the middle stages. The gelding broke free of interference in the home straight and has been placed on its last chance to race truly.

EIPPERMILL raced greenly during the event before tiring to be beaten in excess of 51 metres. After taking into account the recent race record of the mare she was stood down for a period of 14 days and until the completion of two satisfactory trials.

### Race 3 - ART MEEKER MEMORIAL MATRON STAKES (2579 METRES)

MAGIC PEBBLES galloped out and has been placed on its last chance in the standing start draw.

MAJOR GRACE NZ galloped out and has been placed on its last chance in the standing start draw.

JUNIPER galloped out and has been placed on its last chance in the standing start draw.

JUNIPER was held up and unable to be fully tested.

NINE DIAMONDS gave ground to be beaten in excess of 43 metres.

Driver M Jones (NOVA BAXTER) was fined the sum of \$100 after pleading guilty to a charge under AHRR168(1)(a). Particulars were that he allowed his horse to contact the rear of the sulky of MIA RAGAZZA NZ at the 1100 metre mark causing his mare to race roughly.

Driver H Woods (STEPPING STONES) was fined the sum of \$200 after pleading guilty to a charge under AHRR156(2)(a). Particulars were that he used his whip with more than a wrist only flicking motion.

Driver M Pitt (MAJOR GRACE NZ) was cautioned under AHRR156(2)(a) and advised to modify his whip action to prevent any breaches of the whip rule.

STEPPING STONES underwent a post-race veterinary examination which revealed her to be lame. The mare has been stood down until the receipt of a veterinary clearance.

### Race 4 - CAVALOR EQUICARE PACE (2090 METRES)

MY ULTIMATE JIMBO galloped shortly after the start and will continue to out of the mobile draw.

PROMISE STRIDE was checked and broke racing to the first turn then tired to be beaten in excess of 95 metres. The filly has been stood down until the completion of a satisfactory trial.

After an inquiry into the reasons PROMISE STRIDE was checked and broke driver D Ford (MARGARETS CLAN) was suspended for a period of three race dates after pleading guilty to a charge under AHRR165(1)(b). Particulars were that he allowed his mare to shift down the track when not sufficiently clear of the front legs of PROMISE STRIDE racing to the first turn causing that horse to race inside marker pegs and break.

BIGLITTLESIS raced outside the leader throughout.

LUCKSAFORTUNE broke free of interference and has been placed on its last chance to race truly.

SHADY STORY tired to be beaten in excess of 68 metres and has been placed on its last chance to race competitively.

DE MARCO BEACH underwent a post-race veterinary examination after tiring to be beaten in excess of 230 metres. No abnormalities were detected and the gelding has been stood down until the completion of a satisfactory trial.

BETTOR BLAST NZ tired to be beaten in excess of 67 metres and has been placed on its last chance to race competitively.

MY ULTIMATE JIMBO underwent a post-race veterinary examination after tiring to be beaten in excess of 207 metres. No abnormalities were detected and the gelding has been stood down until the completion of a satisfactory trial.

After beginning satisfactorily BETTOR BLAST NZ has been reinstated in the mobile draw.

# Race 5 - E C PLUNKETT MEMORIAL (2090 METRES)

EUREKA NZ was declared a late scratching at 9:48 am due to an elevated temperature. EUREKA NZ has been stood down for a period of 28 days which may be reviewed upon receipt of a veterinary clearance.

Leniency was afforded to horses that gave ground in this event due to the extended margins between the placegetters.

SEAL THE DESTINY showed gate speed to lead before surrendering the lead in the early stages then gave ground over the concluding stages to be beaten in excess of 49 metres.

IDEN MISS LUCY worked forward to the lead in the early stages then gave ground over the concluding stages to be beaten in excess of 47 metres.

EQUITY STRIDE raced outside the leader early before obtaining a trail in the middle stages then gave ground over the concluding stages to be beaten in excess of 49 metres.

WHERES THE GOLD NZ worked forward three wide to race outside the leader.

JACK JAMES was restrained after the start then gave ground over the concluding stages to be beaten in excess of 52 metres.

BEAST MODE was restrained after the start then gave ground over the concluding stages to be beaten in excess of 60 metres.

HEZ RAZOR SHARP gave ground over the concluding stages to be beaten in excess of 53 metres.

ENDEAVOUR STRIDE gave ground over the concluding stages to be beaten in excess of 53 metres.

WE SALUTE YOU gave ground over the concluding stages to be beaten in excess of 43 metres.

#### Race 6 - RICKY DUGGAN 1800 WINNING DRIVES PACE (2090 METRES)

KERMADEC raced outside the leader early before obtaining a trail.

CASTOR TROY was caught wide early before working forward to race outside the leader then obtained a trail.

Driver M Blake (DEBT TILL WE PART) was cautioned under AHRR156(2)(a) and advised to modify her whip action to prevent any breaches of the whip rule.

### Race 7 - LADBROKES HOBART PACING CUP (2579 METRES)

HES IDEAL led the event and withstood a strong challenge for the lead from LIKE A WILDFIRE NZ who worked around the field to challenge for that position.

AHA REACTION NZ tired over the concluding stages to be beaten in excess of 72 metres and has been placed on its last chance to race competitively.

YOUNG ROOSTER underwent a post-race veterinary examination after tiring to be beaten in excess of 190 metres. No abnormalities were detected. This gelding has been stood down for a period of 14 days and until the completion of two satisfactory trials.

AQUA SANCTA NZ underwent a post-race veterinary examination after tiring to be beaten in excess of 104 metres. No abnormalities were detected. This gelding has been stood down until the completion of a satisfactory trial.

MIGHTY FLYING ART NZ tired over the concluding stages to be beaten in excess of 83 metres and has been placed on its last chance to race competitively.

FRANCO HAMPTON NZ tired to be beaten in excess of 58 metres and has been stood down until the completion of a satisfactory trial.

CULLENBURN NZ tired over the concluding stages to be beaten in excess of 83 metres and has been placed on its last chance to race competitively.

DIAMONDS N CASH NZ gave ground over the concluding stages to be beaten in excess of 45 metres.

### Race 8 - TYPEFACE PACE (2090 METRES)

After a confirmed phone call from trainer B Yole, JUMPING JOLT was declared a late scratching at 9:48 am due to an injury to the geldings hind leg. JUMPING JOLT has been stood down for a period of 28 days which may be reviewed upon receipt of a veterinary clearance.

STORMY SANZ was caught wide early before working forward to race outside the leader throughout.

MILITARY MAN NZ was held up early before gaining clear running in the home straight.

KENYA NZ was caught wide early before restraining to the rear of the field.

CHEDDAR VALLEY NZ was caught wide early before restraining to the rear of the field.

A warning was issued to ROCKS ARNT PETS which hung in and contacted marker pegs when giving ground.

KIAVINO STRIDE over raced during the event before giving ground to be beaten in excess of 43 metres.

# Race 9 - TASMANIAN HORSE TRANSPORT PACE (2090 METRES)

IDEN BLACK PRINCE showed gate speed but was unable to maintain the lead when challenged by MAJOR ASSASSIN who assumed the lead and then obtained a trail when PLEASE SHUDDUP NZ worked forward to take over that position.

SPOT ON NZ raced outside the leader in the early stages before obtaining a trail in the middle stages when PROFICIENT NZ worked forward to assume that position.

THE DUDE NZ locked wheels with IDEN BLACK PRINCE momentarily on the home turn.

STONY THE SPY was checked and raced roughly shortly after turning for home the final time when the preceding runners locked wheels.

MAJOR ASSASSIN underwent a post-race veterinary examination after tiring to be beaten in excess of 109 metres. No abnormalities were detected and the gelding has been stood down until the completion of a satisfactory trial.

Driver C Crossland (CAPTAIN COSMONAUT) pleaded guilty to a charge under AHRR156(2)(a). Particulars were that he used his whip in the home straight with more than a wrist only flicking motion. Taking into account that this was Mr Crosslands third offence under this rule within the previous 56 day period Mr Crossland was fined the sum of \$200 and was suspended for 2 race meetings.

An inquiry into the driving tactics of T Yole (MAJOR ASSASSIN) will be conducted at a date to be fixed.

### Race 10 - NUTRIENT SPRINTLANE PACE (1609 METRES)

MIDNIGHT IN MEMPHIS NZ was caught wide early before restraining to the rear of the field.

BOLTNMACH raced outside the leader throughout.

CINOCAL JAMANE shifted out under pressure in the home straight.

MISTA EAGLE utilised the sprint lane to win the event.

Driver T Ford (SMILE LYLE) was fined the sum of \$400 after pleading guilty to a charge under AHRR156(2)(a). Particulars were that she used her whip with more than a wrist only flicking motion.
